Situated in the State of Ohio, County of Muskingum, Township of Clay, Township 14, Range 14, Section 11, and Section 12, bounded and described as follows:

Being part of Marie and Thomas Heiney O.R. Volume 1549, page 501, Parcel Nos. 13-50-12-07-000 and 13-40-11-20-000.

Commencing at a stone found at the Southeast corner of the Northeast quarter of Section 11 and Southwest corner of the Northwest quarter of Section 12; Thence North $89^{\circ}48'14''$ West 163.52 feet to an iron pin found; Thence North $00^{\circ}33'35''$ East 542.15 feet to an iron pin set the place of beginning; Thence North $00^{\circ}33'35''$ East along Hiram Ihinger Volume 612, page 263, 644.75 feet to a stone found; Thence along Larry Burnett Volume 999, page 390, the next two courses and distances – South $89^{\circ}14'30''$ East 167.14 feet to an iron pin found on the line between Section 11 and 12 and North $89^{\circ}58'58''$ East 285.64 feet to a point in the center of Hoop Pole Road passing an iron pin set at 265.64 feet; Thence along the split line of Thomas Heiney O.R. 


