

Survey for Darl Hann

Being all of the remaining portion of three parcels of land transferred to Darl Hann from Robert K. Swope as Executor of the Estate of Olive Lucille Newman as described in Official Record 1533, Page 193 and recorded in the Muskingum County Recorder's Office.

Located in the Southwest quarter of Section 12 and in the Northwest quarter of Section 13, Township 14, Range 14, Clay Township, Muskingum County, State of Ohio.

Beginning at a marked stone found at the Southeast corner of the Northwest quarter of Section 13; thence along the South line of the quarter North 86 deg. 32 min. 41 sec. West - 2628.61 ft. to a marked stone found at the Southwest corner of the Northwest quarter of Section 13; thence along the West line of the section North 03 deg. 22 min. 44 sec. East - 2452.27 ft. to the Southwest corner of a 1.50 acre tract belonging to Gary and Kathy Heiney as described in Deed Volume 1046, Page 289 (ref. iron pin found South 67 deg. 37 min. 24 sec. West - 2.11 ft. and a railroad spike found in the center of Township Road No. 86 at the Northwest corner of Section 13, North 03 deg. 22 min. 44 sec. East - 190.92 ft.); thence along the South line of the 1.50 acre tract North 67 deg. 37 min. 24 sec. East - 379.58 ft. to an iron pin found at the Southeast corner of the 1.50 acre tract; thence along the East line of the 1.50 acre tract North 01 deg. 35 min. 12 sec. West - 193.68 ft. to the center of Township Road No. 86 - Hoop Pole Road and at the Northeast corner of the 1.50 acre tract (ref. passing over an iron pin found at 193.68 ft.); thence along the center of the road the following four courses and distances:

1) North 64 deg. 15 min. 44 sec. East - 21.18 ft.

2) North 58 deg. 45 min. 36 sec. East - 66.38 ft.

4) North 47 deg. 33 min. 29 sec. East - 54.91 ft.

3) North 38 deg. 32 min. 21 sec. East - 94.37 ft. to a survey marker spike set; thence leaving the road South 86 deg. 40 min. 45 sec. East - 1272.00 ft. to the Northwest corner of a 9.54 acre tract belonging to Trent and Sharon Heskett as described in Official Record 1560, Page 40, said corner being in a small run on the North side of Township Road No. 132 - Rider Road; thence along and with a run South 14 deg. 34 min. 56 sec. West - 496.90 ft. to an iron pin found at the Southwest corner of a 3.93 acre tract belonging to Raymond and Constance Magee as described in Official Record 1550, Page 765 and passing the center of Township Road No. 132 and the center of a bridge over the run at 9.71 ft.); thence along the South line of the 3.93 acre tract South 66 deg. 30 min. 32 sec. East - 225.38 ft. to an iron pin found at an angle point therein; thence South 71 deg. 57 min. 16 sec. East - 246.03 ft. to an iron pin found at an angle point therein; thence South 55 deg. 21 min. 51 sec. East - 122.33 ft. to an iron pin found at the Southeast corner of the 3.93 acre tract; thence along the East line of the 3.93 acre tract North 34 deg. 22 min. 45 sec. East - 131.69 ft. to the center of Township Road No. 132 - Rider Road and being at the Northeast corner of the 3.93 acre tract (ref. passing over an iron pin found at 118.55 ft.); thence along the center of the road the following three courses and distances:

1) South 54 deg. 01 min. 14 sec. East - 109.97 ft.

2) South 47 deg. 20 min. 25 sec. East - 177.55 ft.

3) South 52 deg. 54 min. 58 sec. East - 145.68 ft.

thence leaving the road and along the East line of the Northwest quarter of Section 13, South 03 deg. 40 min. 21 sec. West - 2149.22 ft. to the place of beginning (ref. passing over an iron pin found at 18.00 ft.) and containing 162.90 acres, more or less.

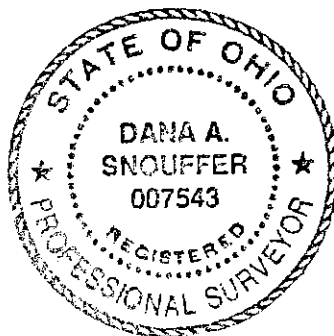

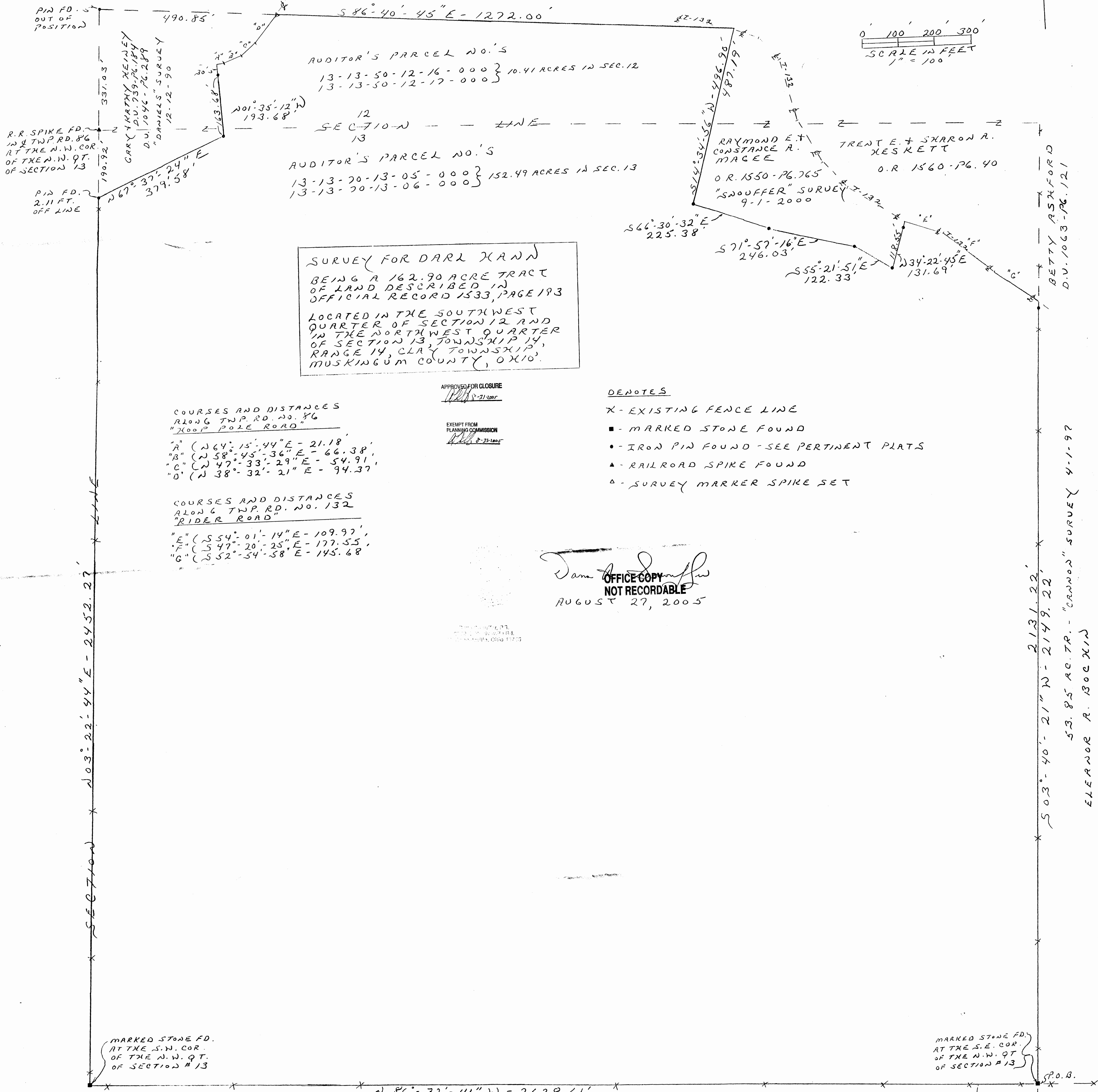
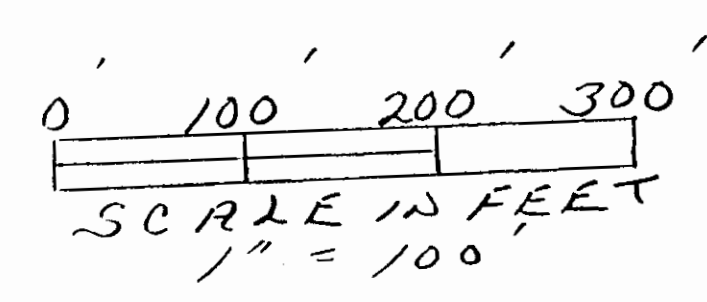
