Situated in the State of Ohio, County of Muskingum, Township of Falls.

Being a part of the Third Quarter, Township 1, Range 8 bounded and described as follows:

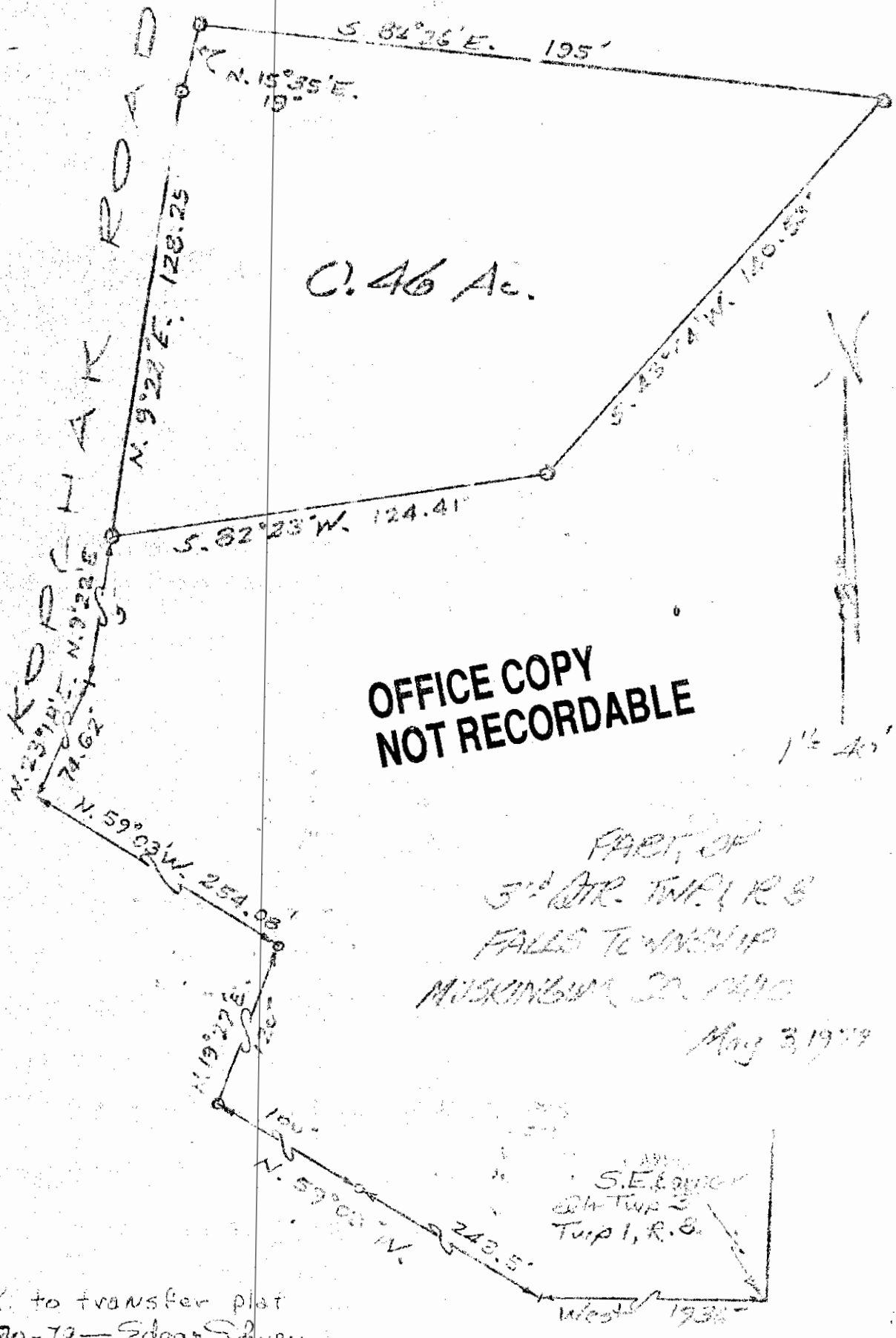
Commencing at the southeast corner of said Quarter Township 3; thence west along the south line of said Quarter Township 1936 feet to a point; thence north 59 degrees 03 minutes west 243.5 feet to an iron pin; thence continuing north 59 degrees 03 minutes west 100 feet to a point, said point being the southeast corner of an .81 acre parcel conveyed to these Grantor's by deed recorded in Deed Book 400, Page 242, of the records of Muskingum County, Ohio; thence along the east line of said .81 acre parcel north 19 degrees 27 minutes east 120 feet to the northeast corner of said .81 acre parcel; thence along the north line of said .81 acre parcel north 59 degrees 03 minutes west 254.08 feet to a stake, said stake being 45 feet right of station 13+70.8 according to a survey made by the State of Ohio in 1965 along Township Road #422; thence along the easterly right-of-way of said Township Road #422 and being the same as surveyed by State of Ohio in 1965 the following four courses and distances, north 23 degrees 18 minutes east 74.62 feet to a stake 50 feet right of station 14+45; thence north 9 degrees 22 minutes east 3 feet to an iron pin and the true place of beginning of the premises herein intended to be described; thence continuing north 9 degrees 22 minutes east 128.25 feet to an iron pin 35 feet right of station 15+70; thence north 15 degrees 35 minutes east 19 feet to an iron pin; thence leaving said right-of-way line south 82 degrees 26 minutes east 195 feet to an iron pin; thence south 43 degrees 04 minutes west 140.53 feet to an iron pin; thence south 82 degrees 23 minutes west 124.41 feet to the true place of beginning, containing forty-six hundredths (0.46) of an acre more or less.
