Thence continuing along the section line, and the south line of said Mahon lands, South 87 degrees 15 minutes 10 seconds East, 843.06 feet to a point on the southwest corner of lands presently owned by Rodney L. and Janee Mahon, (OR 2260-296), from which an iron pipe found bears North 02 degrees 44 minutes 50 seconds East, 1.48 feet;

Thence continuing along the section line, and the south line of said Mahon lands, South 87 degrees 15 minutes 10 seconds East, 180.04 feet to a point on the southwest corner of lands presently owned by Carolyn L. Martin, (OR 2213-510), from which an iron pipe found bears North 02 degrees 44 minutes 50 seconds East, 0.37 feet;

Thence continuing along the section line and the south line of said Martin lands, South 87 degrees 15 minutes 10 seconds East, 188.12 feet to a stone found on the northwest corner of lands presently owned by Anthony Hugill, (OR 2833-209);

Thence along the west line of said Hugill lands, South 02 degrees 53 minutes 59 seconds West, 871.12 feet to a stone found on the northeast corner of lands presently owned by Elizabeth S. and Stephen P. Roberts, (DR 923-129);

Thence along the north line of said Roberts lands, and the north line of lands presently owned by Ricky J. and Rachelle M.
