

Re-Survey of Fracker Farm LLC, (Exhibit A), in Highland Township, Muskingum County

Situated in the State of Ohio, County of Muskingum, Township of Highland, and being part of the Northwest Quarter of Section 19, Township 2, Range 5, United States Military Lands, and being part of the lands presently owned by Fracker Farm Lands LLC, as per Official Record 3228, Page 664, (Exhibit A), and being more particularly described as follows:

Beginning for reference at a stone found on the southwest corner of the Northwest Quarter of Section 19, Township 2, Range 5, United States Military Lands;

Thence along the quarter section line, and the north line of lands presently owned by Dylan T. Ruby, (OR 2843-275), South 87 degrees 18 minutes 53 seconds East, 816.40 feet to a point, and the principal place of beginning;

Thence along the lines of Fracker Farm LLC, (OR 3228-664, Exhibit B), the following three courses:

- 1.) North 06 degrees 27 minutes 50 seconds East, 442.71 feet to an iron pin found, passing an iron pin found at 0.22 feet;
- 2.) North 05 degrees 54 minutes 10 seconds West, 546.90 feet to an iron pin found;
- 3.) North 73 degrees 42 minutes 47 seconds East, 231.41 feet to an iron pin found on the northwest corner of lands presently owned by Fracker Farm LLC, (OR 3228-664, Exhibit A);

Thence through the lands of said Fracker Farm, South 16 degrees 20 minutes 59 seconds East, 148.72 feet to an iron pin found on the northwest corner of lands presently owned by Jeffrey A. and Nedra A. Abele, (OR 2733-527);

Thence along the lines of said Abele lands, the following two courses:

- 1.) South 09 degrees 43 minutes 02 seconds East, 376.47 feet to an iron pin found;
- 2.) North 61 degrees 54 minutes 36 seconds East, 64.36 feet to a pipe found on the northwest corner of lands presently owned by Duard L. Pruitt, (OR 2494-831);

Thence along the lines of said Pruitt lands the following two courses:

- 1.) South 20 degrees 40 minutes 10 seconds East, 145.00 feet to a point;
- 2.) North 61 degrees 49 minutes 52 seconds East, 10.00 feet to an iron pin found on the northwest corner of lands presently owned by Michael Batog, and Carrie Held-Batog, (OR 3150-905);

Thence along the west line of said Batog lands, South 21 degrees 07 minutes 41 seconds East, 79.83 feet to an iron pin found on the northwest corner of lands presently owned by Sandra McAdams, (OR 2634-337);

Thence along the lines of said McAdams lands, the following two courses:

- 1.) South 21 degrees 07 minutes 41 seconds East, 160.00 feet to a point from which an iron pin found bears South 47 degrees 35 minutes 12 seconds West, 3.26 feet;
- 2.) North 61 degrees 43 minutes 14 seconds East, 213.65 feet to a point in the centerline of Friendship Drive, (St, Rte. 83, R\W 60'), passing an iron pin found at 187.99 feet;

Thence along the centerline of said drive, and along the west line of lands presently owned by Thomas G. Taylor Jr., (OR 2089-89), South 20 degrees 40 minutes 22 seconds East, 375.72 feet to an iron pin found on the quarter section line, and the north line of lands presently owned by Messerschmidt Construction Co. Inc., (OR 2662-183);
