McNeal (DR 1062-547), from which a chiseled "X" (set), on a large flat stone bears North 06 degrees 39 minutes 49 seconds East, 3.42 feet;

THENCE along the west line of said McNeal's land, South 02 degrees 20 minutes 18 seconds West for a distance of 646.58 feet to a point on the northeast corner of lands presently owned by M. Dennison (OR 1664-350); passing an iron pipe found at 646.19 feet,

Miller (OR 1143-60), South 86 degrees 21 minutes 17 seconds West for a distance of 2620.33 feet to an iron pipe found on the east line of lands presently owned by R. C. Varner, Trustee, (OR 1161-774), passing a point at 1470.19 feet, from which an iron pipe found bears North 03 degrees 38 minutes 43 seconds West, 2.07 feet, the centerline of Cottage Hill Road at 1495.19 feet, an iron pin found at 1526.85 feet, and an iron pin found at 1813.56 feet;

THENCE along said Varner's east line, North 01 degrees 54 minutes 30 seconds East for a distance of 869.72 feet to the principal place of beginning, containing 45.33 acres, more or less.
