

Situated in the State of Ohio, County of Muskingum, Township of Hopewell.

Being a part of the Northeast Quarter of Section 15, Township 1, Range 9 bounded and described as follows:

Commencing at the northeast corner of the northeast quarter of Section 15; thence west along the section line a distance of 988.95 feet to an iron pin found; thence south 1 degree 39 minutes east 700.26 feet to an iron pin found and the true place of beginning of the premises herein intended to be described; thence south 1 degree 39 minutes east 707.66 feet to a point in the center of Flint Ridge Road; thence along the center of said road south 89 degrees 11 minutes west 155.0 feet to a point; thence leaving said road north 1 degree 39 minutes west 709.87 feet to an iron pin; thence east a distance of 155.05 feet to the true place of beginning, containing two and fifty-two hundredths (2.52) acres more or less.

Excepting therefrom an easement along the entire east side of the above described 2.52 acre parcel 20 feet wide and to be used by the owner or owners of the 2.49 acres north of the above described 2.52 acres.
