BEGINNING AT A POINT AT THE NORTHWEST CORNER OF LOT 10;

THENCE WITH THE NORTH LINE OF LOT 10 ALSO THE SOUTH LINE OF LOT 1 OF THE BRUNER-MALLETT SUBDIVISION (BRUNER LAND CO. DEED VOLUME 1529, PAGE 676), SOUTH 85 DEGREES 33 MINUTES 14 SECONDS EAST 262.47 FEET TO AN IRON PIN SET, PASSING AN EXISTING IRON PIN (5/8 INCH REBAR) AT 30.00 FEET;

THENCE LEAVING SAID LINE AND TRAVERSING THROUGH THE LANDS OF D. AND J. COOPER (DEED BOOK VOLUME 1089, PAGE 247), SOUTH 05 DEGREES 00 MINUTES 00 SECONDS WEST 297.53 FEET TO AN IRON PIN SET;

THENCE NORTH 85 DEGREES 00 MINUTES 00 SECONDS WEST 262.72 FEET TO A POINT ON THE WEST LINE OF LOT 10, SAID POINT ALSO BEING IN TOWNSHIP ROAD 415 (NORTH HOPEWELL ROAD), PASSING AN IRON PIN SET AT 174.08 FEET;

THENCE WITH THE SAID LOT LINE, NORTH 05 DEGREES 03 MINUTES 08 SECONDS EAST 50.00 FEET TO A POINT;

THENCE LEAVING SAID LOT LINE AND WITH THE SOUTH LINE OF A 1.00 ACRE TRACT CONVEYED TO E. ZWAHLEN III (DEED BOOK VOLUME 1039, PAGE 327), SOUTH 85 DEGREES 00 MINUTES 00 SECONDS EAST 212.68 FEET TO AN EXISTING IRON PIN (3/4 INCH PIPE), PASSING AN EXISTING IRON PIN (3/4 INCH PIPE) AT 20.00 FEET;








DETAIL "A"
