LEGAL DESCRIPTION
for Maylen Peters estate

Situated in the State of Ohio, County of Muskingum, Township of Hopewell, and being part of the northwest, northeast and southeast quarters of Section 5, Township 18, Range 15, and being all those lands intended to be described in Deed Volume 1140, page 459; being further bounded and described as follows:

Beginning at an iron pin set at the northwest corner of the northeast quarter of said Section 5, thence, south 89 degrees – 44 minutes – 41 seconds east, 1395.30 feet along the north line of said Section and the south line of Section 21 (Licking County), to an iron pin found at the southeast corner of said Section 21 (Licking County);

Thence, continuing south 89 degrees – 44 minutes – 41 seconds east, 981.61 feet along Township Road 412 to an iron pin found;

Thence, south 00 degrees – 14 minutes – 53 seconds west, 731.40 feet to an iron pin found;

Thence, north 89 degrees – 44 minutes – 28 seconds west, 9.53 feet to an iron pin found in the centerline of said Township Road 412;

Thence, along said centerline the following six (6) courses and distances:

1. along a curve to the right having a radius of 140.88 feet, a length of 163.07 feet, a delta of 66 degrees – 19 minutes – 14 seconds, the chord of which bears south 33 degrees – 30 minutes – 30 seconds west, 154.12 feet to a point;
2. south 66 degrees – 40 minutes – 07 seconds west, 282.61 feet to a point;
3. along a curve to the left having a radius of 383.29 feet, a length of 228.80 feet, a delta of 34 degrees – 12 minutes – 07 seconds, the chord of which bears south 49 degrees – 34 minutes – 05 seconds west, 225.42 feet to a point;
4. south 32 degrees – 28 minutes – 01 seconds west, 506.19 feet to a point;
5. along a curve to the right having a radius of 140.73 feet, a length of 93.57 feet, a delta of 38 degrees – 05 minutes – 43 seconds, the chord of which bears south 51 degrees – 30 minutes – 48 seconds west, 91.86 feet to a point;
6. south 70 degrees – 33 minutes – 40 seconds west, 118.49 feet to a point;

Thence, leaving said road, south 89 degrees – 41 minutes – 40 seconds west, 85.62 feet to an iron pin found;

Thence, south 00 degrees – 32 minutes – 25 seconds west, 79.99 feet to a railroad spike set;

Thence, along the perimeter of an existing cellular tower easement and access road (to be retained by grantor herein), the following six (6) courses and distances:




