

DESCRIPTION OF SURVEY FOR MARILYN CARSON,
RHEA TAYLOR, AND CAROL LENHART

Situated in the State of Ohio, County of Muskingum, Township of Hopewell:

Being part of the Southwest Quarter of Section #7, Township#18, Range#15, of the Congress Lands East of the Scioto River, **being part of the** Marilyn Carson, Rhea Taylor, and Carol Lenhart property recorded in Official Record Volume 2188, Page 72 of said county's deed records, further being known as Muskingum County **Auditor's Parcel Number 25-77-07-05-000**, and more particularly described as follows;

Commencing at the unmarked corner for the Southwest and Southeast Quarters of Section #7, the Northwest and Northeast Quarters of Section #18, being in the roadbed of Mount Perry Road (CR#30);

TIE-THENCE North 02 degrees 39 minutes 25 seconds East 900.09 feet along the half Section line for the Southwest and Southeast Quarter for Section #7 to an unmarked common northeastern corner for the Carol J. Lenhart property recorded in Official Record Volume 2189, Page 16, also being in the roadbed of said Mount Perry, said corner being the place of beginning for the property herein intended to be described;

- #1- **THENCE North 87 degrees 22 minutes 00 seconds West 265.00 feet** into said Southwest Quarter of Section #7 leaving said Mount Perry Road and along said Carol J. Lenhart property to an axle (found) passing an iron pin (found) at 24.92 feet;
- #2- **THENCE North 05 degrees 36 minutes 30 seconds West 101.30 feet** through said Marilyn Carson, Rhea Taylor, and Carol Lenhart property to an iron pin (set);
- #3- **THENCE North 08 degrees 02 minutes 40 seconds East 231.79 feet** continuing into said Marilyn Carson, Rhea Taylor, and Carol Lenhart property to an iron pin (set);
- #4- **THENCE North 51 degrees 37 minutes 30 seconds East 14.21 feet** continuing into said Marilyn Carson, Rhea Taylor, and Carol Lenhart property to an iron pin (set);
- #5- **THENCE South 87 degrees 20 minutes 35 seconds East 247.08 feet** continuing into said Marilyn Carson, Rhea Taylor, and Carol Lenhart property to an unmarked point, on said half section line, being in the roadbed of said Mount Perry Road, passing an iron pin (set) at 221.88 feet;
- #6- **THENCE South 02 degrees 39 minutes 24 seconds West 340.23 feet** along said Marilyn Carson, Rhea Taylor, and Carol Lenhart property and the along west line for the Arthur T. Jr and Judith Handel property recorded in Official Record Volume 1927, Page 241 to the place of beginning, **containing 2.10 acres**, of which 0.16 acres are within the right of way for Mount Perry Road (CR#30).

The bearings within this description are based on State Plane Coordinate Grid (Ohio South 1983) derived from GPS Observations. Iron pins (set) are 5/8" rebar with identification caps (C.R.Harkness P.L.S.6885).






