Survey Split of DNR, LLC Lands in Jackson Township, Muskingum County

Situated in the State of Ohio, County of Muskingum, Township of Jackson, Quarter Township 1, and being part of Farm Lots 10, and 11, Township 3, Range 9, United States Military Lands, and being part of the lands presently owned by DNR, LLC as per Official Record 2548, Page 42, and being more particularly described as follows:

Beginning for reference and the principal place of beginning at a stone found, on the northwest corner of Farm Lot 11, Quarter Township 1, Township 3, Range 9, United States Military Lands;

Thence along the east line of lands presently owned by Elaine Slaughter, (DR 1160-421), North 03 degrees 32 minutes 45 seconds East, 25.08 feet to a pipe found on the southwest corner of lands presently owned by Eveline M. Parr, (OR 2260-664);

Thence along the south line of said Parr lands, South 86 degrees 52 minutes 30 seconds East, 299.62 feet to a point on the southwest corner of lands presently owned by Raymond Carlos McElfresh, (OR 1797-869), from which an iron pipe found is perpendicular to the north and at 2.02 feet;

Thence along the south line of said McElfresh lands, South 86 degrees 52 minutes 30 seconds East, 341.82 feet to an iron pin found on the northwest corner of lands presently owned by Nicole Schockling, (OR 2300-732);

Thence along the west line of said Schockling lands, South 02 degrees 26 minutes 22 seconds West, 841.35 feet to an iron pin found, on the northwest corner of lands presently owned by Tony, and Holly Noland, (OR 1939-512);

Thence along the west line of said Noland lands, South 02 degrees 26 minutes 30 seconds West, 564.69 feet to an iron pin found on the southwest corner of said Noland lands;

Thence through the lands presently owned by DNR, LLC, (OR 2548-42) the following two courses:

1.) North 88 degrees 20 minutes 42 seconds West, 648.69 feet to an iron pin found on the Lot 11\12 lot line;

2.) North 02 degrees 43 minutes 55 seconds East, 572.41 feet to an iron pin found on the southeast corner of said Slaughter lands;

Thence along the east line of said Slaughter lands, North 02 degrees 42 minutes 25 seconds East, 825.12 feet to the principal place of beginning, containing 20.95 acres more or less, and being part of Auditor's Parcel Number 29-20-71-30-000.

Subject to all legal recorded easements and right of ways.

Iron pins set are 5\8 inch rebars , 30 inches long, with plastic identification caps.

Bearings are based on Ohio State Plane Coordinate System, NAD 83, South Zone, Grid North, as per GPS observations.
