Beginning for a point of reference at the Northwest corner of the Northeast Quarter of Section 15 and marked by a found iron pin;

thence N 89° 22' 27" E along the North line of said Northeast Quarter a distance of 978.52 feet to the True Point of Beginning of the herein described tract and marked by a set iron pin, passing set iron pins at 86.29 feet and 653.57 feet;

thence continuing N 89° 22' 27" E along said North line a distance of 367.31 feet to a point marked by a set iron pin and being the Northeast corner of subject title lands;

thence S 0° 26' 59" E along the Easterly line of subject title lands a distance of 1071.35 feet to a point on the center line of O'Dell Road, passing a set iron pin at 1049.35 feet;

thence S 65° 58' 13" W along the center line of O'Dell Road a distance of 400.77 feet to a point;

thence N 0° 26' 59" W a distance of 1230.54 feet to the True Point of Beginning, passing set iron pins at 30.00 feet and 462.54 feet;
