PART OF AUDITORS PARCEL
29-40-14-12-000 (3.000 ACRES)

Situated in the Northwest Quarter of Section 14, T-3-N, R-9-W, U.S.M.L., Jackson Township, Muskingum County, Ohio. Being part of the lands of Grace Johnston last conveyed in Deed Book 970 Page 345 of the Muskingum County Deed Records, and being described as follows:

Commencing at a found iron pin marking the Southeast corner of the Northwest Quarter of Section 14; thence, N.00°12'10"E. a distance of 1,680.40 feet along the East line of said Quarter Section to a point in the center of Dove Road (T.R. 318-A); thence, S.89°30'57"W. a distance of 200.01 feet along the center of Dove Road to a point, **BEING THE POINT OF BEGINNING**;

thence, S.89°30'57"W. a distance of 333.50 feet along the centerline of Dove Road to a point;

thence, S.00°12'10"W. a distance of 281.58 feet to a found iron pin, passing a found iron pin at 17.60 feet;

thence, S.00°12'10"W. a distance of 110.27 feet through the lands of G. Johnston (970/345) to a set rebar;

thence, N.89°30'57"E. a distance of 333.50 feet through said Johnston lands To a set rebar on the West line of a 5.006 Acre Parcel;

thence, N.00°12'10"E. a distance of 391.85 feet along said parcel to the point of beginning, passing a found iron pin at 371.85'.

The above described parcel contains 3.000 acres, more or less, and is subject to all legal easements and right of ways. All set rebars are 5/8" x 30" rebars with plastic I.D. caps. North is based upon an assumed meridian.





PART OF AUDITORS PARCELS
