

### Vacation of a Portion of Mound Street and an Alley in Fazeysburg

Being a part of land located in the State of Ohio, Muskingum County, Jackson Township, Village of Fazeysburg, J.W. Frazier's 2<sup>nd</sup> Addition to Fazeysburg (Plat Book 4, page 87), Section 19, Township 3 North, Range 9 West, United States Military Lands, bounded and described as follows:

**Beginning** at the southwest corner of Lot 19 of J.W. Frazier's 2<sup>nd</sup> Addition to Fazeysburg (Plat Book 4, page 87), also being on the north line of 4<sup>th</sup> Street (66' wide), and on the east line of Mound Street (60' wide)

thence along the north line of 4<sup>th</sup> Street (66' wide) and across Mound Street (60' wide) North 88 degrees 22 minutes 02 seconds West 60.00 feet to the west line of Mound Street (60' wide);

thence leaving the north line of 4<sup>th</sup> Street (66' wide) and along the west line of Mound Street (60' wide) North 01 degrees 37 minutes 58 seconds East 181.50 feet to a point, being the northwest corner of J.W. Frazier's 2<sup>nd</sup> Addition to Fazeysburg (Plat Book 4, page 87);

thence along the north line of J.W. Frazier's 2nd Addition to Fazeysburg (Plat Book 4, page 87), also being the north line of an alley (16.5' wide), South 88 degrees 22 minutes 02 seconds East 456.00 feet to a point on the east line of J.W. Frazier's 2nd Addition to Fazeysburg (Plat Book 4, page 87);

thence along the east line of J.W. Frazier's 2nd Addition to Fazeysburg (Plat Book 4, page 87) South 01 degrees 37 minutes 58 seconds West 16.50 feet to a point, being the southeast corner of said alley (16.5' wide) and the northeast corner of Lot 24 of J.W. Frazier's 2nd Addition to Fazeysburg (Plat Book 4, page 87);

thence along the south line of said alley (16.5' wide) North 88 degrees 22 minutes 02 seconds West 396.00 feet to the northwest corner of Lot 19 of J.W. Frazier's 2nd Addition to Fazeysburg (Plat Book 4, page 87), passing an axle found at 66.00 feet, an iron pin found at 132.00 feet and an iron pin found at 198.00 feet;

thence along the west line of Lot 19, also being the east line of Mound Street (60' wide) South 01 degrees 37 minutes 58 seconds West 165.00 feet to the place of beginning, containing 0.400 acres, more or less.
