Situated in the Village of Frazeytsburg, Muskingum County, Ohio. Being 70.00 feet off the North end of Lot #4 of the Iron Addition to the Village of Frazeytsburg as recorded in Plat Book 1 page 258 of the Muskingum County Plat records and being more particularly described as follows:

Beginning at an iron pin found at the Northeast corner of lot #5;

thence, S.00°00'00"E. a distance of 70.00 feet along the east line of lot #5 to a point;

thence, N.90°00'00"E. a distance of 66.00 feet through lot #4 to a point on the West line of lot #3;

thence, N.00°00'00"W. a distance of 70.00 feet along the West line of said lot #3 to the Northwest corner of said lot;

thence, S.90°00'00"W. a distance of 66.00 feet along the South line of Furnace Street to the point of beginning.

The above described parcel contains 0.106 acres, more or less, and is subject to all legal easements and right of ways. North is based upon an assumed meridian. All set iron pins are 3/4" x 30" pipes with I.D. caps.





Commencing at an iron pin found at the Southwest corner of Lot 4 of said Iron Addition; Thence North 00°14'18" East along Lot 4 105.00 feet to an iron pin set the place of beginning; Thence North 00°14'18" East 38.07 feet to an iron pin found; Thence North 89°58'02" East along Furnace Street (60' wide) 66.00 feet to a point from which an iron pin found bears North 89°58'02" East 0.41 feet; Thence South 00°14'18" West along Lot 3 38.11 feet to an iron pin set; Thence North 90°00'00" West along the split line of Lot 4 and Randy Prouty 66.00 feet to the place of beginning containing 0.058 Acres more or less.

Bearings are based on Third Street bearing North 90°00'00" West.


