Thence along the north line of said alley, North 88 degrees 29 minutes 34 seconds West, 286.09 feet to an iron pin found on the southwest corner of lands presently owned by Julie L. Baker, Trustee, (OR 2688-615), passing a point at 122.50 feet, from which an iron pin found bears North 02 degrees 13 minutes 04 seconds East, 1.36 feet;

Thence along the east line of said Baker lands, North 02 degrees 13 minutes 56 seconds East, 166.10 feet to an iron pin set, on the south line of Second Street,(R\W 66');

Thence along the south line of said Parsonage Tract, North 88 degrees 27 minutes 59 seconds West, 133.79 feet to a point from which an iron pin found bears North 19 degrees 21 minutes 06 seconds West, 1.53 feet;

Thence along the west line of said Parsonage Tract, North 02 degrees 15 minutes 18 seconds East, 77.00 feet to the principal place of beginning, containing 0.236 Acres, more or less, and being part of Auditor's Parcel Number 29-61-18-01-000.
