AUDITORS PARCELS  
#29-61-14-20-000 (Part)

Situated in the Village of Frazeytsburg, Muskingum County, Ohio Being part of lot #10 of the Town Plat of Frazeytsburg (Formerly the Town of Knoxville), recorded in Deed Book I page 250, as conveyed to Frederick and Mary Smeltzer in Deed Book 794 page 294 of the Muskingum County deed records and being described as follows:

Beginning at the Northeast corner of lot #10;

thence, S.00°10'00"W. a distance of 47.48 feet along the east line of lot #10 to a set iron pipe;

thence, N.90°00'00"W. a distance of 13.90 feet through lot #10 to a set iron pipe;

thence, N.00°10'00"E. a distance of 47.48 feet through lot #10 to a set iron pipe on the South line of a Public Alley;

thence, S.90°00'00"E. a distance of 13.90 feet along south line of said alley to the point of beginning.

The above described parcel contains 0.015 acres, more or less, and is subject to all legal easements and right of ways. All set iron pipes are 3/4" x 30" pipes with plastic I.D. caps. North is based on an assumed meridian.



794 PAGE 294 OF THE MUSKINGUM COUNTY DEED RECORDS.


