ALL OF PARCELS

#30-29-61-15-04-000 (0.232 A.)
#30-29-61-15-05-000 (0.232 A.)

Situated in the Village of Frazeyburg, Muskingum County, Ohio. Being the remaining part of lots #4 and #5 of J.W. Blizzard's Subdivision (P.B. 1 Pg. 225) as conveyed to John M. Frazier in Deed Book 1055 page 613 of the Muskingum County deed records and being described as follows:

Beginning at a set iron pipe in the Northwest corner of lot #5 of J.W. Blizzard's Addition as recorded in Plat Book 1 page 255;

thence, N.89°37'20"E. a distance of 132.00 feet along the South line of Third Street (State Route #16) to a set iron pipe at the Northwest corner of Lot #3;

thence, S.00°01'10"E. a distance of 153.28 feet along the West line of said lot to a found iron pin on the corner of the lands of H. & S. Drilling Co. (1077/094);

thence, S.89°37'20"W. a distance of 132.00 feet along the North line of said H. & S. lands to a found iron pin on the East line of a Public alley;

thence, N.00°01'10"W. a distance of 153.28 feet along said alley to the point of beginning.

The above described parcel contains 0.464 acres, more or less, and is subject to all legal easements and right of ways. All set iron pipes are 3/4" x 30" pipes with plastic I.D. caps. North is based upon an assumed meridian.



AN ASSUMED MERIDIAN


