SITUATED IN THE VILLAGE OF FRAZEYSBURG, MUSKINGUM COUNTY, OHIO. BEING PARTS OF LOTS #20 & #21 AND THE NORTH HALF OF A VACATED ALLEY AS PLATTED IN THE ORIGINAL TOWN PLAT OF FRAZEYSBURG (FORMERLY KNOXVILLE) RECORDED IN DEED BOOK I PAGE 250 OF THE MUSKINGUM COUNTY DEED RECORDS AND BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS:

BEGINNING AT AN IRON PIN FOUND IN THE SOUTHEAST CORNER OF LOT #20 OF THE ORIGINAL TOWN PLAT OF FRAZEYSBURG; THENCE, N.56°28'01"E. A DISTANCE OF 14.42 FEET ALONG THE SOUTH LINE OF LOT #21 TO THE SOUTHWEST CORNER OF J & H CRONIN (969/061), MARKED BY A FOUND IRON PIN; THENCE, N.00°10'00"E. A DISTANCE OF 54.92 FEET ALONG THE WEST LINE OF SAID CRONIN LANDS TO A FOUND IRON PIN; THENCE, S.73°47'36"W. A DISTANCE OF 98.49 FEET THROUGH THE LANDS OF D & F KING (944/305) TO AN IRON PIN FOUND ON THE WEST LINE OF LOT #20; THENCE, S.00°10'00"W. A DISTANCE OF 83.25 FEET ALONG THE WEST LINE OF LOT #20 TO AN IRON PIN SET IN THE CENTER OF A VACATED ALLEY 16.5' WIDE, PASSING AN IRON PIN FOUND AT 24.75'; THENCE, N.90°00'00"E. A DISTANCE OF 22.95 FEET ALONG THE CENTERLINE OF SAID ALLEY TO AN IRON PIN FOUND ON THE NORTHERLY LINE OF NORTH CANAL STREET; THENCE, N.50°25'25"E. A DISTANCE OF 12.95 FEET ALONG THE NORTHERLY LINE OF NORTH CANAL STREET TO THE SOUTHWEST CORNER OF LOT #21; THENCE, N.51°27'22"E. A DISTANCE OF 63.55 FEET ALONG THE SOUTHERLY LINE OF SAID LOT #20 TO THE POINT OF BEGINNING.


