- North 64 degrees 05 minutes 46 seconds West, 154.82 feet to a point in the centerline of Shannon Road, passing an iron pin set at 129.82 feet;

Thence along said centerline, North 05 degrees 26 minutes 29 seconds West, 290.00 feet to a point on the southwest corner of lands presently owned by Todd A. and Donna L. Hanks, (OR 2538-617);

Thence along the south line of said Hanks lands the following three courses:

Thence along west line of said Hershberger lands, and the township line, South 02 degrees 09 minutes 48 seconds West, 522.14 feet to the principal place of beginning, passing iron pins found at 133.31 feet, and 383.51 feet, containing 5.00 acres more or less, and being part of Auditor's Parcel Number 29-90-21-31-000;

Iron pins set are 5\8 inch rebars, 30 inches long, with plastic identification caps.


