

Oliver Vestrie

Situated in the State of Ohio, County of Muskingum, Township of Licking, part of Lot 16, First Quarter of Second Township, Range 9, bounded and described as follows:

Being part of Oliver E. and Shirley Vestrie Deed Vol. 1036, Page 449, Parcel No. 35-35-10-61-02-000.

Commencing at a stone at the Southeast Corner of Lot 16; Thence North 88°16'42" West 1908.78 feet to an iron pin; Thence North 29°17'28" West 107.04 feet to an iron pin set the place of beginning; Thence North 29°17'28" West 110.00 feet along the split line of Oliver Vestrie to an iron pin found; Thence along the split line of Oliver E. and Shirley Vestrie Vol. 1036, Page 449 the next five courses and distances: South 81°30'41" West 216.77 feet to an iron pin found, South 13°39'24" East 30.80 feet to an iron pin found, South 76°03'46" West 16.47 feet to an iron pin found, North 13°39'24" West 32.37 feet to an iron pin found, and South 81°30'41" West 106.28 feet to the center of Vicker Hill Road passing an iron pin found at 78.28 feet; Thence along the center of Vicker Hill Road North 06°00'06" West 307.06 feet to a point; Thence leaving Vicker Hill Road and along the split lines of said Oliver E. and Shirley Vestrie Vol. 1036, Page 449 the next three courses and distances: North 88°09'11" East 702.87 feet to an iron pin set passing iron pins set at 29.87 feet and 287.21 feet, South 2°57'07" East 374.33 feet to an iron pin set, and South 90°00'00" West 300.00 feet to the place of beginning containing 5.19 acres more or less:

Bearings are based on the South line of Lot 16 bearing North 88°16'42" West.

Iron pins set are No. 5 reinforced bars 30 inches long with plastic ID caps.


