Thence North 22 degrees 49 minutes 27 seconds West, 27.72 feet to a point at the terminus of said easement on a south line of the above described tract, containing .02 acres, more or less, and being part of Auditor's Parcel Number 35-40-01-14-002.

Also appended to the above described tract is another existing twenty feet wide Ingress, Egress Easement described as follows:

- 7.) North 36 degrees 34 minutes 20 seconds West, 21.51 feet to an iron pin set at the terminus of this easement, containing 0.19 acres, more or less, and being part of Auditor's Parcel Number 35-40-01-14-002.

Subject to all legal recorded easements and right of ways.

Iron pins set are 5\8 inch rebars, 30 inches long, with plastic identification caps.
