ALL OF PARCEL
38-70-21-26-000 (4.732 Acres)

Situated in the Northeast Quarter of Section 21, T-3-N, R-7-W, U.S.M.L., Madison Township, Muskingum County, Ohio. All the lands of Jerry and Doris Bowman as last conveyed in Deed Book 619 page 69 of the Muskingum County Deed records, and being described as follows:

Commencing at the Southeast corner of the Northeast Quarter of Section 21; thence, N.05°59'13"E. a distance of 203.45 feet along the East line of said quarter section to a found iron pipe, BEING THE POINT OF BEGINNING;

thence, N.57°04'46"W. a distance of 379.00 feet along the lands, now or formerly, owned by D. & K. Boyce (1131/334) to a found iron pipe;

thence, N.11°10'29"E. a distance of 663.00 feet along said Boyce lands to a point in the center of T.R. 161 (Prospect Church Road), passing a found iron pipe at 638.00 feet;

thence, S.49°53'20"E. a distance of 335.75 feet along the centerline of said road to a point on the east line of the Northeast Quarter of Section 21;

thence, S.05°59'13"W. a distance of 643.60 feet along said Quarter Section line to the point of Beginning, passing a set rebar at 25.00 feet and passing a found iron pin at 596.60 feet.

The above described parcel contains 4.732 acres, more or less, and is subject to all legal easements and right of ways. All set rebars are 5/8" x 30" rebars with plastic I.D. caps. North is based upon an assumed meridian.




