

Description of a 78.182 acre tract
in Meigs Township, Muskingum County, Ohio

Situated in the State of Ohio, County of Muskingum, Township of Meigs, Township 12 North, Range 11 West, Quarter Township 3, and being part of the northeast quarter of Section 30 of the Congress Lands by Greenville Treaty, being the remainder of a 118.924 acre tract as described in Volume 1004, Page 371 (part of Auditor's Parcel #'s 40-70-30-16-000, 40-70-30-21-000) to Twila L. Alexander (record reference to those of the Recorders Office, Muskingum County, Ohio), and being more particularly bounded and described as follows:

Commencing at a concrete monument found locating the Northwest corner of the Northeast Quarter of said Section 30, thence South $00^{\circ}28'32''$ East, 289.15 feet along the west line of said Northeast Quarter to an iron pin found, being on the easterly line of a 51.860 acre tract as described in Volume 2005, Page 466 to Micheal G. Dingey, being the southwest corner of a 1.157 acre tract as described in Volume 580, Page 620 to Malcom Nabb, being the True Point of Beginning:

Thence easterly along the south line of said 1.157 acre tract, South $63^{\circ}16'27''$ East, 75.00 feet to an iron pin found, being the southeast corner of said 1.157 acre tract, being the northwest corner of a 7.882 acre tract as described in Volume 1682, Page 38 to Paul A. Tedrick;

Thence along said 7.882 acre tract the following 4 courses:

South $08^{\circ}22'21''$ East, 307.55 feet to an iron pin found;
South $22^{\circ}11'04''$ East, 462.26 feet to an iron pin found;
North $57^{\circ}53'38''$ East, 475.61 feet to an iron pin found;
North $04^{\circ}11'40''$ East, 274.71 feet to an iron pin found, being the southeast corner of a 1.201 acre tract as described in Volume 1019, Page 227 to Edwin J. Rayner;


Thence northerly along the east line of said 1.201 acre tract, North $05^{\circ}28'57''$ East, 223.20 feet to the center of County Road 31 (Rural Dale Road);




