Being 100.568 acres, more or less (21,063 acres, all of parcel #: 42-50-18-01, in the northeast quarter of section 18) (79,503 acres, all of parcel #: 42-60-18-02, 42-60-18-03, in the northwest quarter of section 19) in the fourth quarter of township 3 north, range 5 west, United States Military Lands, in the township of Monroe, in the county of Muskingum, in the State of Ohio, and more particularly described as follows:

Beginning at a stone found at the northwest corner of section 19, said stone found being the TRUE POINT OF BEGINNING;

thence, along the section line, (sections 12 & 19) S.87°19'40"E. 1322.12' to a 5/8" steel pin set;

thence, along the north & south eighth line the following 2 courses:

1. thence, S.03°02'25"W. 675.00' to a 5/8" steel pin set;
2. thence, continuing S.03°02'25"W. 1937.67' to a 5/8" steel pin found;

1. thence, N.87°36'00"W. 225.85' to a 5/8" steel pin found;
2. thence, continuing N.87°36'00"W. 332.89' to a 5/8" steel pin found;
3. thence, continuing N.87°36'00"W. 184.00' to a 5/8" steel pin found;
4. thence, continuing N.87°36'00"W. 334.12' to a 5/8" steel pin found;
5. thence, continuing N.87°36'00"W. 248.88' to a 5/8" steel pin found;
6. thence, continuing N.87°36'00"W. 345.00' to a 5/8" steel pin set;

thence, along the section line (sections 18 & 19) N.02°54'05"E. 2823.92' to a 5/8" steel pin set;

thence, along the section line (sections 18 & 13) S.88°47'22"E. 355.01' to the TRUE POINT OF BEGINNING, containing 100.568 acres, more or less, including public road right-of-way and is subject to all easements, rights-of-way, or restrictions, whether recorded or implied.




