Being 2.083 acres, more or less (part of #:42-60-20-02-000) in the northeast quarter of section 20, in the fourth quarter of township 3 north, range 5 west, United States Military Lands, in the township of Monroe, in the county of Muskingum, in the State of Ohio, and more particularly described as follows:

Commencing at a 5/8" steel pin found at the southeast corner of the north half of the northeast quarter of Section 20;

thence, along the Guernsey-Muskingum County line, S.00°16'16"W. 67.69' to a point in the centerline of Granny's Knob Road, CR 17, said point being the TRUE POINT OF BEGINNING;

thence, continuing along the Guernsey-Muskingum County line the following 2 courses:

1. thence, continuing S.00°16'16"W. 22.54' to a 5/8" steel pin set;
2. thence, continuing S.00°16'16"W. 317.46' to a 5/8" steel pin set;

thence, through the property of David J. & Miriam A. Mast, DB1142/186 the following 3 courses:

1. thence, N.89°43'44"W. 250.00' to a 5/8" steel pin set;
2. thence, N.00°16'16"E. 385.90' to a 5/8" steel pin set;
3. thence, continuing N.00°16'16"E. 16.46' to a point in the centerline of Granny's Knob Road, CR 17;

thence, along the centerline of Granny's Knob Road, CR 17 the following 2 courses:

1. thence, S.70°47'23"E. 148.15' to a point;
2. thence, along a tangent curve, concave to the north having the following properties:
delta = 23°04'26"; radius = 276.99'; arc = 111.55'; chord = S.82°19'36"E. 110.80' to the TRUE POINT OF BEGINNING, containing 2.083 acres, more or less, including public road right-of-way and is subject to all easements, rights-of-way, or restrictions, whether recorded or implied.

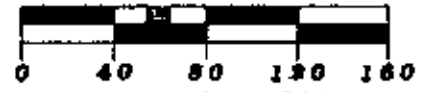

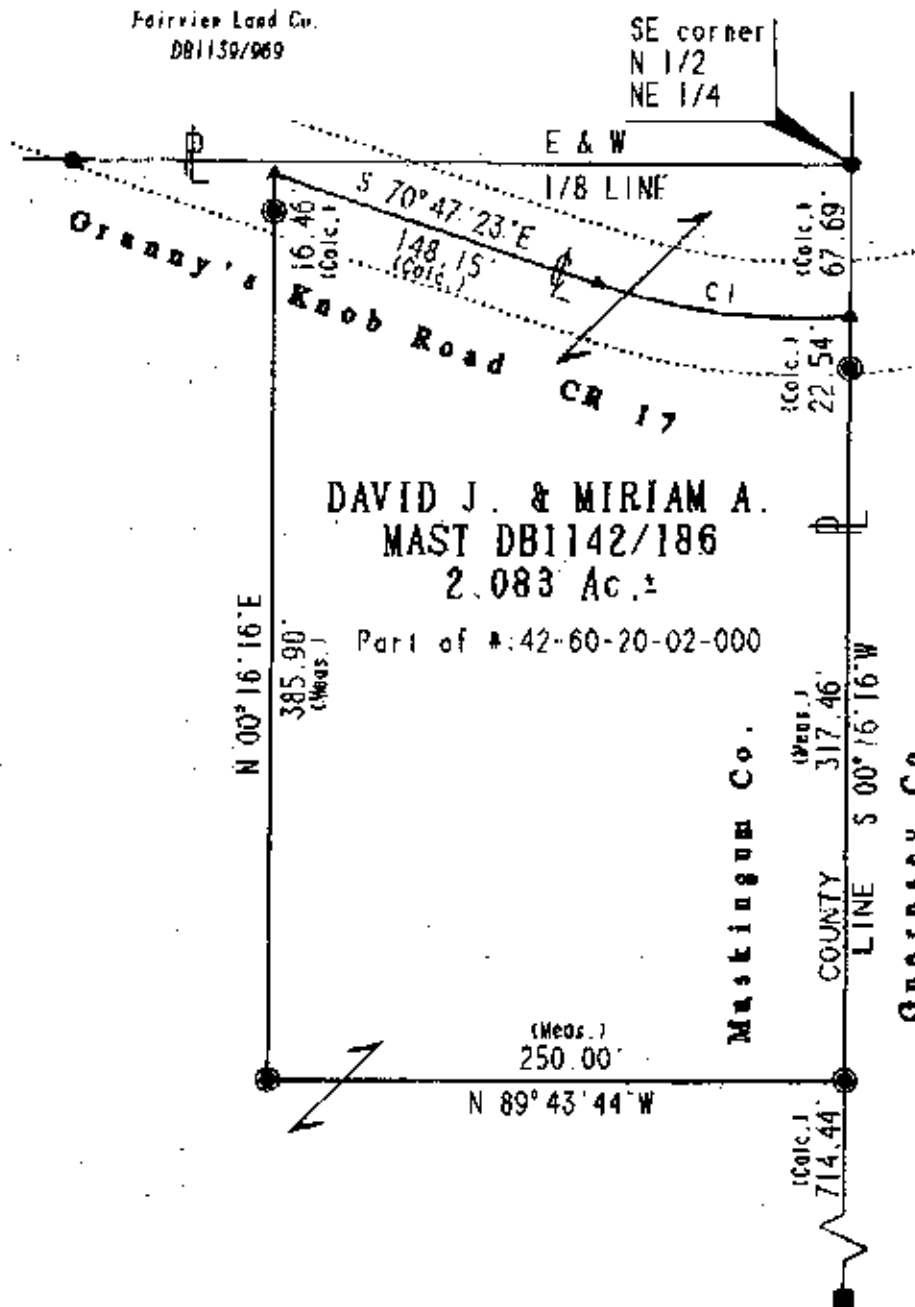
