WARRANTY DEED

KNOW ALL MEN BY THESE PRESENTS:

That Terry D. & Sharon L. Blythe hereinafter referred to as the Grantor (as used herein, Grantor includes the plural and words in the masculine include the feminine) in consideration of the sum of _____ Dollars (\$ _____) to him paid by the State of Ohio, the Grantee, the receipt whereof is hereby acknowledged, does hereby grant, bargain, sell and convey to the said Grantee, its successors and assigns forever, the following described real estate:

The lands herein described are situated in the southeast quarter of Section 4, Township 2N, Range 8W, Muskingum Township, Muskingum County, State of Ohio. Being further described as follows:

PARCEL NO. 39WD

Being a parcel of land lying on the left side of the centerline of survey for Mus-60-22.59 made by the Ohio Department of Transportation, and recorded in Plat File _____, Slot _____, of the Muskingum County Plat Records and being located within the following described points in the boundary thereof.

Beginning at a railroad spike set in the intersection of the center of Shannon Road (County Road 48) and the center of State Route 60, at Station 0+00 of Shannon Road and at Station 1481+54.52 as shown on the plan of Mus-60-22.59 as mentioned above;

thence, **N02°36'46"E** a distance of **626.22 feet** along the existing centerline of existing State Route 60 to a P.K. nail set at centerline station 1487+80.74 of existing State Route 60;

thence, on a curve to the left a distance of 123.34 feet, with a radius of 1909.96 feet and whose chord bears **N0°45'46"E** a distance of **123.32 feet**, along the centerline of right of way to a P.K. Nail set at centerline station 1489+04.07 of existing State Route 60;

thence, on a curve to the left a distance of 311.10 feet, with a radius of 1432.40 feet and whose chord bears **N07°18'33"W** a distance of **310.49 feet**, along the centerline of right of way to a P.K. Nail set at centerline station 1492+15.17 of existing State Route 60;

thence, on a curve to the left a distance of 96.99 feet, with a radius of 1909.89 feet and whose chord bears **N14°59'09"W** a distance of **96.98 feet**, along the centerline of right of way to a P.K. Nail set, located 0.26 feet right of centerline station 1493+12.15 of proposed State Route 60; said point being the **TRUE POINT OF BEGINNING**;

thence, **N87°59'02"W** a distance of **84.67 feet**, along the southern property line of Terry D. & Sharon L. Blythe (1109/69) to a set rebar, located 80.00 feet left of centerline station 1493+39.53 of existing State Route 60;

thence, **N16°01'09"W** a distance of **715.09 feet**, through said lands to a set rebar, located 65.00 feet left of centerline station 1500+55.00 of existing State Route 60;

thence, **N72°46'08"E** a distance of **65.00**, through said lands to a point on the existing centerline of right of way, being centerline station 1500+55.00 of existing State Route 60;

thence, **S17°13'52"E** a distance of **716.49 feet**, along the centerline of right of way to a point being centerline station 1493+38.51, of existing State Route 60;

thence, on a curve to the left with a distance of 26.35 feet, with a radius of 1909.90 feet and whose chord bears **S16°50'10"E** a distance of **26.35 feet** to a point, said point being the **TRUE POINT OF BEGINNING**;
