Begins at the northeast corner of section 5; thence north 00 degrees 00 minutes 01 seconds west along the section and township line a dist. per. of 2792.10 feet to a point in Dutch School Road; thence south 07 degrees 51 minutes 56 seconds west along said road a dist. per. of 994.45 feet to the true place of beginning for the parcel herein intended to be described; thence south 00 degrees 23 minutes 13 seconds west a distance of 403.63 feet to an existing iron pin; thence south 11 degrees 14 minutes 41 seconds east a distance of 618.44 feet to a point in Chapman Road; thence south 83 degrees 36 minutes 24 seconds east a distance of 526.70 feet to a point; thence south 79 degrees 58 minutes 20 seconds east along a rd. road a distance of 101.91 feet to a point; thence south 00 degrees 51 minutes 56 seconds west a distance of 142.00 feet to another point; thence south 83 degrees 36 minutes 24 seconds east a distance of 518.70 feet to an existing iron pin; thence north 08 degrees 57 minutes 52 seconds east a distance of 284.63 feet to an existing iron pin; thence north 02 degrees 44 minutes 01 seconds west a distance of 134.74 feet to a point in Dutch School Road; thence north 07 degrees 51 minutes 56 seconds east along a rd. road a distance of 138.08 feet to the true place of beginning containing Seven and Twenty Eight (7.28) hundredths acres more or less.


