Commencing at the northeast corner of section 5; thence north 07 degrees 35 minutes 07 seconds west along the section and township line a distance of 2792.10 feet to a point in Dutch School Road; thence south 07 degrees 34 minutes 56 seconds west along said road a distance of 994.39 feet to the true place of beginning for the parcel herein intended to be described; thence south 11 degrees 23 minutes 15 seconds east a distance of 402.63 feet to an existing iron pin; thence south 11 degrees 14 minutes 41 seconds east a distance of 618.32 feet to a point in Shannon Road; thence south 83 degrees 16 minutes 12 seconds east a distance of 523.70 feet to a point; thence south 79 degrees 18 minutes 27 seconds west along said road a distance of 101.01 feet to a point; thence south 81 degrees 51 minutes 06 seconds east a distance of 227.00 feet to a point; thence south 83 degrees 36 minutes 24 seconds east a distance of 116.00 feet to an existing iron pin; thence north 08 degrees 37 minutes 32 seconds east a distance of 284.63 feet to an existing iron pin; thence north 82 degrees 44 minutes 01 seconds west a distance of 134.74 feet to a point in Dutch School Road; thence north 07 degrees 51 minutes 56 seconds east along said road a distance of 138.08 feet to the true place of beginning containing Seven and Twenty Eight (7.28) hundredths acres more or less.

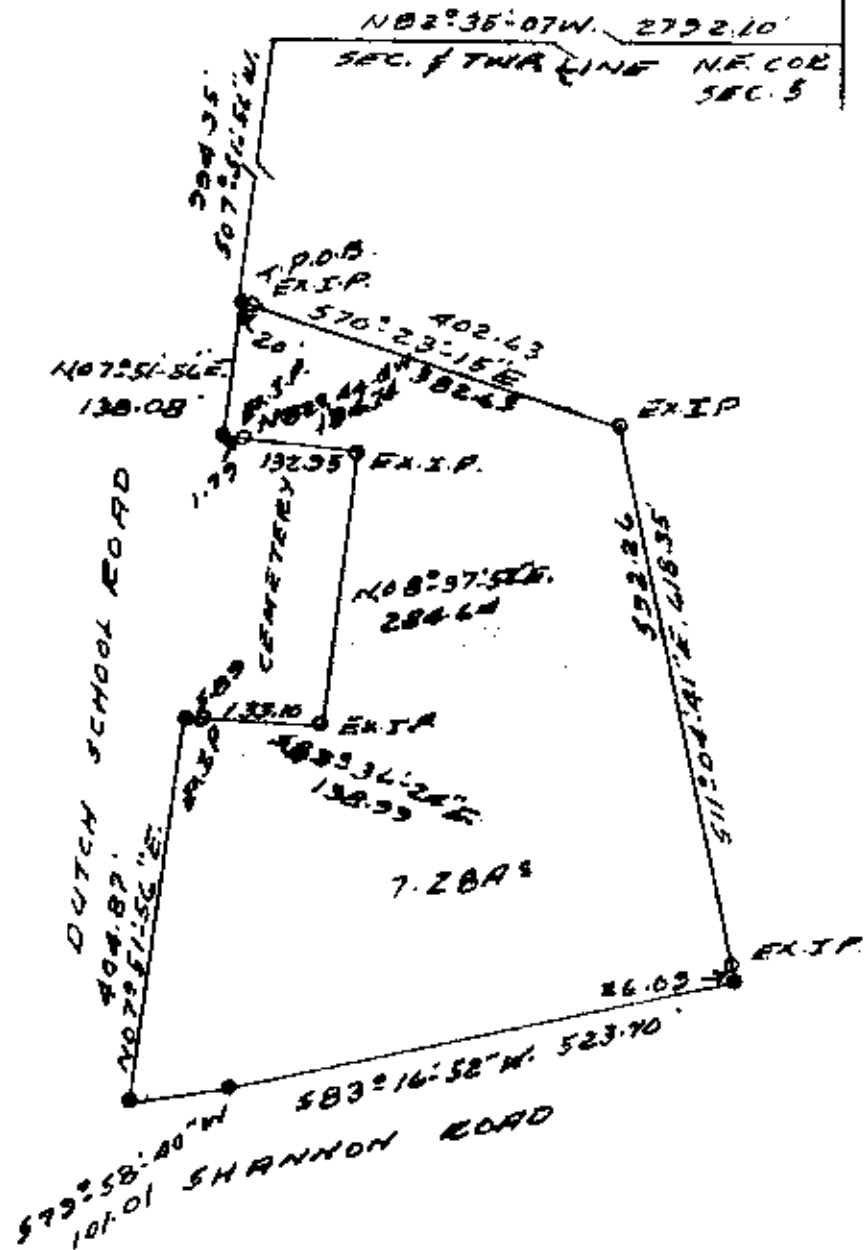
