

Adjoiner Split to Lands formerly owned by Joseph McFarland

Situated in the State of Ohio, County of Muskingum, Township of Muskingum, and being part of the Southwest Quarter of Section 7, Township 2, Range 8, United States Military Lands, and being part of lands presently owned by Ronald E. Riley, OR 2242-590, and DR 990-165, and being more particularly described as follows:

Beginning for reference at an iron pin found in Fawn Drive, at the southeast corner of the Southwest Quarter of Section 7;

Thence along the section line and in Fawn Drive, North 87 degrees 53 minutes 42 seconds West, 864.09 feet to a point on a southeast corner of lands presently owned by Ronald E. Riley,(DR 990-165), and the principal place of beginning;

Thence continuing along the section line, North 87 degrees 53 minutes 42 seconds West, 46.97 feet to a point;

Thence through said Riley lands, and lands also owned by Ronald E. Riley,(OR 2242-590), the following four courses:

- 1.) North 14 degrees 48 minutes 11 seconds East, 214.07 feet to an iron pin found, on the northwest corner of lands formerly owned by Joseph McFarland,(OR 1935-188), passing an iron pin set at 34.69 feet;
- 2.) North 02 degrees 07 minutes 29 seconds East, 79.77 feet to an iron pin set;
- 3.) North 87 degrees 59 minutes 12 seconds East, 196.34 feet to an iron pin set;
- 4.) South 05 degrees 37 minutes 28 seconds East, 94.93 feet to an iron pin found on the northeast corner of said formerly owned McFarland lands;

Thence along the north line of said formerly owned McFarland lands, North 87 degrees 50 minutes 21 seconds West, 208.63 feet to the northwest corner of said formerly owned McFarland lands;

Thence along the west line of said formerly owned McFarland lands, South 02 degrees 07 minutes 57 seconds West, 208.84 feet to the principal place of beginning, passing an iron pin found at 183.84 feet, containing 0.52 acres more or less.

Subject to all legal recorded easements and right of ways.

Iron pins set are 5/8 inch rebars , 30 inches long, with plastic identification caps.

Bearings are based on the south line of Section 7, as being North 87 degrees 53 minutes 42 seconds West, as per DR 990-165.





