Commencing at an iron pin found at the southwest corner of said northwest quarter of section 22; thence N 1 26 04 E (the base of bearings for this description is true north by an observation of the sun) along the west line of said quarter 707.22 feet to a stone found at the true place of beginning for the following described parcel; thence N 1 08 47 E along the east line of property owned by John D. Campbell (Vol.1117, Pg.20) a distance of 259.02 feet to an iron pin found; thence S 74 32 38 E 216.41 feet to an iron pin found on the west line of Lot 38 of Idlewood Subdivision No. 2 (P.B.14, Pg.97); thence S 1 17 29 W along the west line of said Lot 38 and Lot 59 a distance of 77.50 feet to an iron pin found; thence S 1 15 30 W along the west line of said Lot 59 a distance of 132.49 feet to a point which bears S 74 06 09 E 0.65 of a foot from an iron pin found; thence N 87 37 53 W along the north line of Lisakim Lane and the north line of Lot 31 of Idlewood Subdivision (P.B.14, Pg.83) a distance of 209.29 feet to the true place of beginning containing one and thirteen hundredths (1.13) acres more or less.


