20 foot ingress egress easement

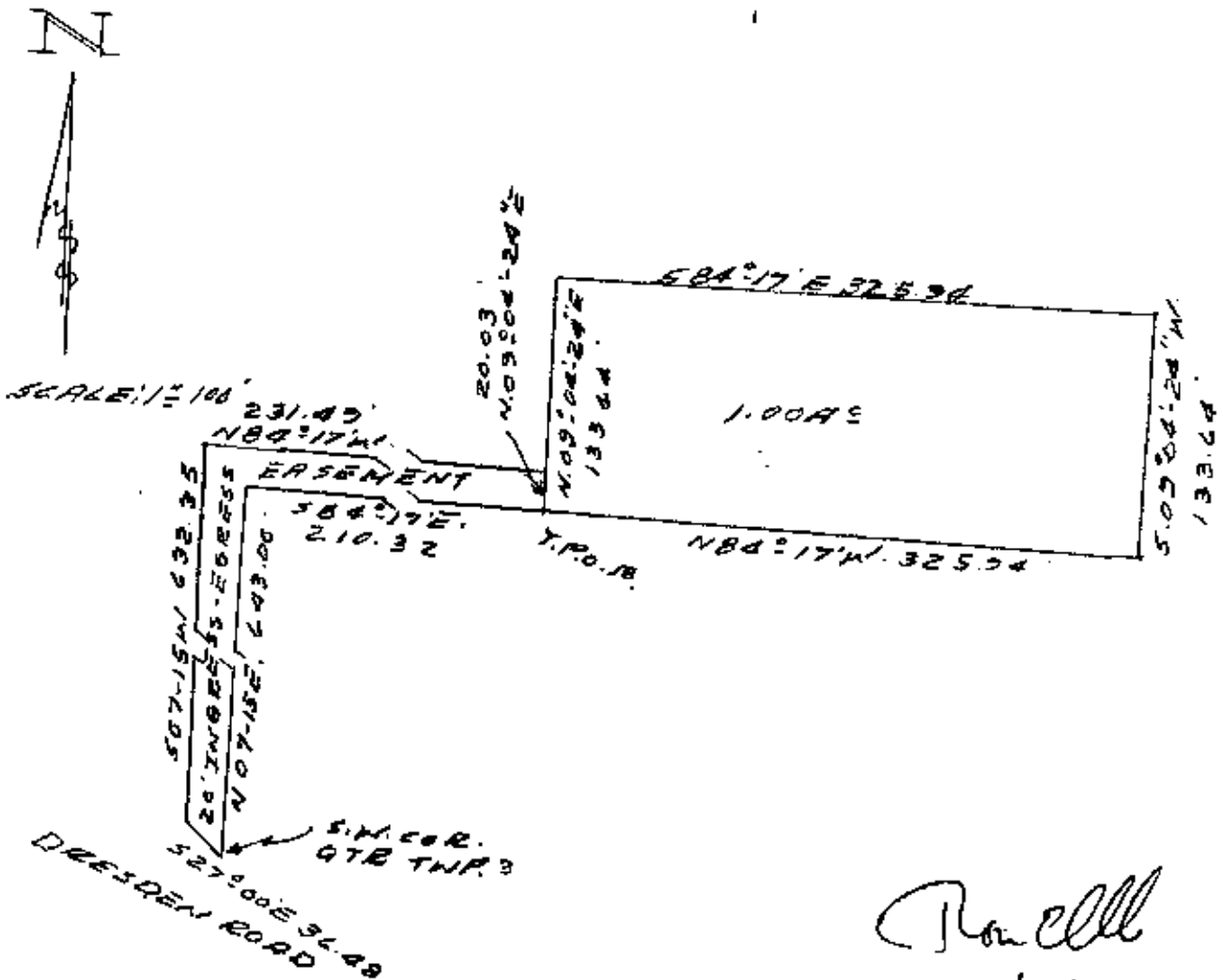
