

Situated in the State of Ohio, County of Muskingum, Township of Muskingum, Quarter Township 3, Township 2 N, Range 7 W and Being further described as follows.

Commencing at a point at the intersection of the west line of the said Range 7 W and the south line of the said Township 2 N, thence, North $00^{\circ} 04' 42''$ East, 640.93 feet along the said range line to a point at an existing iron pin on a common line between G. Appleman et al (Deed Book 1093, Page 599) and D. Parson (Deed Book 848, 345) thence South $89^{\circ} 46' 04''$ East, 995.10 feet along the south line of the said D. Parson and A. Miller (Deed Book 831, Page 308) to an iron pin - set - at the point of beginning of the parcel herein described.

thence, continuing South $89^{\circ} 46' 04''$ East, 291.10 feet along a south line of the said A. Miller to a point at an iron pin - set,

thence, South $00^{\circ} 10' 37''$ West, 358.94 feet across G. Appleman et al (Deed Book 1093, Page 599) to a point at an iron pin - set - on the north line of a proposed road,

thence, with a curve to the left (Radius 239.76 feet) an arc distance of 179.47 feet along the north right-of-way line of the proposed road to a point at an iron pin - set - the long chord bears North $68^{\circ} 21' 03''$ West, 175.31 feet,

thence, North $89^{\circ} 47' 43''$ West, 77.98 feet along the proposed right-of-way to a point of curve at an iron pin - set,

thence, with a curve to the right (Radius 50.00 feet) an arc distance of 78.51 feet to a point at an iron pin - set - the long chord bears North $44^{\circ} 48' 33''$ West, 70.69 feet,

thence, North $00^{\circ} 10' 37''$ East, 245.01 feet along the right-of-way line of a proposed street to the point of beginning, containing 2.034 acres.

Iron pins - set - are $5/8''$ X 30" re-bars with identification caps.

Easement for ingress and egress shall be granted until the proposed road shall be platted and accepted by the county. The easement shall be 50.00 feet wide -- 25 feet on each side of the following described centerline. Commencing at the intersection of the west line of Range 7 and the common line between Falls and Muskingum Townships, thence South $89^{\circ} 39' 22''$ East, 46.94 feet to a point on the east side of pavement of Dresden Road at the point of beginning of the easement herein described, thence, North $63^{\circ} 02' 31''$ East, 224.30 feet, thence, with a curve (Radius 300.00 feet) to the left 148.30 feet the chord bears North $48^{\circ} 52' 49''$ East, 146.80 feet,

thence, North 34° 43' 06" East, 25.94 feet,
thence, with a curve (Radius 300.00 feet) to the right 290.53
feet, the chord bears North 62° 27' 42" East, 279.31
feet,
thence, South 89° 47' 43" East, 514.21 feet.


