

LEGAL DESCRIPTION

20.4406 ACRES

Situate in the State of Ohio, County of Muskingum, Township of Newton, Part Section 11, Township 17 North, Range 15 West, USML, and being part of a 34.122 acre tract of land conveyed to Michael T. Rockwell, Matthew S. Rockwell and Paul A. Rockwell as recorded in O.R. 2074, page 419 (all references to deeds, plats, surveys, etc. refer to the Muskingum County Recorder's Office or Engineer's Office), being more particularly described as follows;

COMMENCING FOR REFERENCE at a 6" MAG nail set at the southwest corner of the Southwest 1/4 of said Section 11, said point also being on the centerline of Workman Road (Township Road 479);

Thence along the centerline of said Workman Road and the south line of the Southwest 1/4 of said Section 11 South 85°46'52" East for a distance of 610.80 feet, to a 2" MAG nail set, said point being the **TRUE POINT OF BEGINNING** of the herein described tract of land;

Thence leaving lines and across said 34.122 acre tract, on a new dividing line for the following four (4) courses:

1. **North 03°15'31" East** for a distance of **272.00 feet**, to an iron pin set, passing an iron pin set at 20.00 feet;
2. **North 36°25'09" West** for a distance of **123.86 feet**, to an iron pin set;
3. **North 63°21'54" West** for a distance of **185.00 feet**, to an iron pin set;
4. **South 85°26'39" West** for a distance of **102.00 feet**, to an iron pin set on the east line of a 7.878 acre tract of land conveyed to Michael T. Rockwell and Tessa D. Rockwell as recorded in D.V. 1094, page 547;

Thence along the east line of said 7.878 acre tract **North 03°15'31" East** for a distance of **895.52 feet**, to an iron pin set at the northeast corner of said 7.878 acre tract, said point also being on the north line of the south 1/2 of the Southwest 1/4 of said Section 11;

Thence along the north line of south 1/2 of the Southwest 1/4 said Section 11 **South 85°35'14" East** for a distance of **776.83 feet**, to an iron pin set;

Thence leaving said lines and across said 34.122 acre tract, on a new dividing line **South 02°53'10" West** for a distance of **1314.06 feet**, to a 2" MAG nail set on the south line of the Southwest 1/4 of said Section 11, passing an iron pin set at 1294.06 feet;

Thence along the south line of the southwest 1/4 of said Section 11 and said centerline **North 85°46'52" West** for a distance of **435.33 feet**, to the **TRUE POINT OF BEGINNING** containing **20.4406 acres**, more or less.
