

Situated in the State of Ohio, County of Muskingum, Township of Newton:

Being part of the Southwest Quarter, of Section #1, Township #17, Range #15, of the Congress Lands East of the Scioto River, **being part of the CountryTyme** property recorded in Official Record Volume 1986, Page 621 of said county's deed records, further being known as Muskingum County **Auditor's Parcel Number 47-04-01-29-000**, and more particularly described as follows;

Commencing at a stone (found) marked at the Northwest corner of said Southwest Quarter of Section #1, also being the common corner for the Northwest Quarter of said Section #1 and for the Northeast and Southeast Quarters of Section #2 of said Township and Range;

- TIE-1 THENCE South 03 degrees 08 minutes 30 seconds West 1112.65 feet** along the common line for said Sections #1 and #2 to an iron pin (set) South of Township Road #277;
- TIE-2 THENCE South 54 degrees 04 minutes 45 seconds East 58.99 feet** into said Southwest Quarter and through said CountryTyme property to an iron pin (set);
- TIE-3 THENCE South 70 degrees 12 minutes 10 seconds East 152.35 feet** continuing through said CountryTyme property to an iron pin (set);
- TIE-4 THENCE South 85 degrees 33 minutes 25 seconds East 95.41 feet** continuing through said CountryTyme property to an iron pin (set);
- TIE-5 THENCE South 87 degrees 31 minutes 00 seconds East 138.26 feet** continuing through said CountryTyme property to an iron pin (set) at the place of beginning for the property herein intended to be described;

- #9- THENCE South 24 degrees 41 minutes 10 seconds East 228.04 feet** to an iron pin (found) in the intersection of Opera Road (Township Road #277) and Slack Road (Township Road #90), said pin being a common corner for said CountryTyme property and for the Lyle Plummer property recorded in Official Record Volume 1655, Page 779;
- #10- THENCE South 68 degrees 53 minutes 05 seconds West 102.19 feet** along said Slack Road and through said CountryTyme property to an unmarked point;
- #11- THENCE South 70 degrees 54 minutes 50 seconds West 295.64 feet** continuing along said road and through said CountryTyme property to an unmarked point;
- #12- THENCE along a curve to the left having, a chord bearing South 67 degrees 23 minutes 25 seconds West 149.72 feet**, a radius of 1218.22 feet, and arc length of 149.81 feet, continuing along said road and through said CountryTyme property to an unmarked point;

- #13- **THENCE South 63 degrees 52 minutes 05 seconds West 104.72 feet** continuing along said road and through said CountryTyme property to an unmarked point;
- #14- **THENCE along a curve to the left having, a chord bearing South 61 degrees 36 minutes 00 seconds West 172.05 feet**, a radius of 2173.89 feet, and arc length of 172.09 feet, continuing along said road and through said CountryTyme property to an unmarked point;
- #15- **THENCE North 23 degrees 49 minutes 55 seconds West 848.64 feet** leaving said road and continuing through said CountryTyme property to an iron pin (set), passing an iron pin (set) at 30.00 feet;
- #16- **THENCE North 03 degree 08 minutes 30 seconds East 569.03 feet** continuing through said CountryTyme property to the place of beginning, containing **20.98 acres**, of which 0.38 acres are within the right of way of Slack Road (Township Road #90).


