

DESCRIPTION OF SURVEY FOR COUNTRYTYME DEVELOPMENT, LTD.

Situated in the State of Ohio, County of Muskingum, Township of Newton:

Being part of the Southwest Quarter, of Section #1, Township #17, Range #15, of the Congress Lands East of the Scioto River, **being part of the CountryTyme Development, Ltd. property recorded in Official Record Volume 2011, Page 524 of said county's deed records, further being known as Muskingum County Auditor's Parcel Number 47-04-01-29-007**, and more particularly described as follows;

Commencing at a stone (found) marked at the common corner for Sections #1, #2, #11, and #12 of said Township and Range;

- TIE** THENCE South 86 degrees 49 minutes 30 seconds East 916.86 feet along the common line for said Sections #1 & #12 to an iron pin (found) at a common corner for said CountryTyme property and for the Galloway Land Company property recorded in Official Record Volume 2011, Page 519, also being the place of beginning for the property herein intended to be described, passing an iron pin (found) at 734.19 feet;
- #1-** THENCE North 02 degrees 47 minutes 25 seconds East 538.36 feet into said Section #1 and along a common line for said CountryTyme and Galloway properties to an unmarked point in the centerline of Slack Road (Township Road #90), passing iron pins (set) at 200.00 feet and 400.00 feet, also passing an iron pin (found) at 508.36 feet;
- #2-** THENCE along a curve to the right having, a chord bearing North 63 degrees 10 minutes 50 seconds East 52.14 feet, a radius of 2173.89 feet, and arc length of 52.14 feet, along said road to an unmarked point;
- #3-** THENCE North 63 degrees 52 minutes 05 seconds East 104.72 feet continuing along said road to an unmarked point;
- #4-** THENCE along a curve to the right having, a chord bearing North 64 degrees 12 minutes 55 seconds East 14.78 feet, a radius of 1218.22 feet, and arc length of 14.78 feet, continuing along said road to an unmarked point;
- #5-** THENCE South 02 degrees 47 minutes 25 seconds West 622.84 feet leaving said road and through said CountryTyme property to an iron pin (set) on the common line for said Sections #1 & #12, passing iron pins (set) at 30.00 feet, 222.84 feet, and 422.84 feet;
- #6-** THENCE North 86 degrees 49 minutes 30 seconds West 149.97 feet along said Section line to the place of beginning, **containing 2.00 acres**, of which 0.08 acres are within the right of way for Slack Road (Township Road #90).

The bearings within this description are based on State Plane Coordinate Grid (Ohio South 1983) derived from GPS Observations. Iron pins (set) are 5/8" rebar with identification caps (C.R.Harkness P.L.S.6885).


