

Situated in the State of Ohio, County of Muskingum, Township of Newton:

Being part of the East Half, of the Northwest Quarter, of Section #12, Township #17, Range #15, of the Congress Lands East of the Scioto River, being a corrective survey of the property transferred from Mary E. Mahle property described in deed reference Deed Book Volume 1040, Page 97, to Scott Mahle described in deed reference Deed Book Volume 1104, Page 554, of said county's deed records, also being known as Muskingum County Auditor's Parcel Number 47-04-12-06-001, and more particularly described as follows;

Commencing at an iron pin (set) at the Northwest corner, of said East Half, of the Northwest Quarter; thence S 00 17 00 W 698.82 feet along the West line of said East Half being the East line of the Darrol Chamber property described in deed reference Deed Book Volume 582, Page 120, to an iron pin (set) at the Southeast corner of said Chamber property, also being the Northeast corner of the G & M Ellis property described in deed reference Deed Book Volume 993, Page 215; thence S 00 17 00 W 573.71 feet continuing along the West line of said East Half and East line of said Ellis property to the center line of County Road #33 (Bagley Road), being the Southeast corner of said Ellis property, also being the Northeast corner of the Oxford Oil property described in deed reference Deed Book Volume 1070, Page 343; thence S 68 00 00 E 404.30 feet along the center of said road and through said Mary E. Mahle property to a pk nail (set) at the place of beginning for the property herein intended to be described;


- #1- thence N 12 49 10 W 92.64 feet leaving said road and continuing through said Mary E. Mahle property to an iron pin (set);
- #2- thence N 07 54 10 E 507.78 feet continuing through said Mary E. Mahle property to an iron pin (set);
- #3- thence N 35 42 10 E 318.03 feet continuing through said Mary E. Mahle property to an iron pin (set);
- #4- thence S 71 23 00 E 124.18 feet continuing through said Mary E. Mahle property to an iron pin (set);
- #5- thence S 07 54 10 W 897.43 feet continuing through said Mary E. Mahle property to the center line of said Bagley Road, passing an iron pin (set) at 872.43 feet;
- #6- thence N 71 25 30 W 241.75 feet along the center line of said road and continuing through said Mary E. Mahle property to the place of beginning containing 5.01 acres.

The bearings within the description are based on the North line of Section #12 as described in deed reference Deed Book Volume 582, Page 120, being N 90 00 00 E. Bearings are shown in a format of Degrees, Minutes, and Seconds. Iron pins (set) are 5/8" rebar with identification caps (C.R.Harkness P.L.S.6885).






