BEING A PART OF THE SOUTHEAST QUARTER OF SECTION 6 AND A PART OF THE NORTHEAST QUARTER OF SECTION 7, TOWNSHIP 15, RANGE 14, OF THE CONGRESS LANDS EAST OF THE SCIOTO RIVER, NEWTON TOWNSHIP, MUSKINGUM COUNTY, OHIO AND BEING FURTHER DESCRIBED AS FOLLOWS:

COMMENCING AT AN EXISTING IRON PIN (3/4 INCH PIPE) AT THE SOUTHEAST CORNER OF THE SOUTHEAST QUARTER OF SECTION 6;

THENCE WITH THE SOUTH LINE OF SECTION 6, SOUTH 89 DEGREES 38 MINUTES 49 SECONDS WEST 203.50 FEET TO AN IRON PIN SET AT THE NORTHWEST CORNER OF A TRACT CONVEYED TO C. ELSON AS RECORDED IN DEED VOLUME 761, PAGE 101 OF THE MUSKINGUM COUNTY DEED RECORDS, SAID IRON PIN BEING THE PLACE OF BEGINNING OF THE TRACT HEREIN INTENDED TO BE DESCRIBED;

THENCE LEAVING THE SOUTH LINE SECTION 6 AND WITH THE WEST LINE OF THE SAID ELSON TRACT AND ALSO WITH THE WEST LINE OF A TRACT CONVEYED TO H. AND B. ZIEGLER (DEED VOLUME 481, PAGE 33), SOUTH 10 DEGREES 49 MINUTES 14 SECONDS WEST, PASSING AN IRON PIN SET AT 565.76 FEET, A TOTAL DISTANCE OF 1117.48 FEET TO AN EXISTING IRON PIN (3/4 INCH PIPE) AT THE SOUTHWEST CORNER OF THE SAID ZIEGLER TRACT AND THE NORTHWEST CORNER OF A TRACT CONVEYED TO R. THENCE WITH THE NORTH LINE OF THE SAID G. CARSON TRACT, SOUTH 88 DEGREES 09 MINUTES 21 SECONDS WEST, PASSING AN IRON PIN SET AT 315.45 FEET, A TOTAL DISTANCE OF 831.65 FEET TO AN IRON PIN SET ON THE EAST LINE OF A TRACT CONVEYED TO W. AND N. HARPER (DEED VOLUME 602, PAGE 248);


