Situated in the State of Ohio, County of Muskingum, Township of Newton, Township 15, Range 14, part of the Southeast Quarter of Section 12 and bounded and described as follows:

North Commencing at the Southeast corner of the Southeast Quarter of Section 12; thence on section line North $89^{\circ} 25' 30''$ West 1233.67 feet to an iron pin set, the place of beginning; thence along the North line of A. Nunley, Deed Vol. 657, Page 50, and M. Wayne, Deed Vol. 821, Page 102, North $89^{\circ} 25' 30''$ West 387.24 feet to an iron pin found; thence leaving said section line North along J. Glass, Vol. 751, Page 84, $0^{\circ} 31' 16''$ East 405.30 feet to the center of Township Road 486, passing an iron pin found at 380.30 feet; thence along center of Township Road 486 and R. Wisecarver the following three (3) courses and distances, South $52^{\circ} 28' 13''$ East 121.24 feet to a point, South $61^{\circ} 00' 05''$ East 80.07 feet to a point and South $77^{\circ} 37' 38''$ East 208.61 feet to a point; thence along the West line of Steve Wayne South $3^{\circ} 05' 24''$ East 252.16 feet to the place of beginning, passing an iron pin set at 20.00 feet, containing 2.65 acres more or less.

Bearings are based on the South line of the Southeast Quarter of Section 12 bearing North $89^{\circ} 25' 30''$ West.

Iron pins set are No. 5 reinforcing bars 30 inches long with plastic I. D. caps.

Being all of Auditor's Parcel Number 47--47--32--12--23--000.

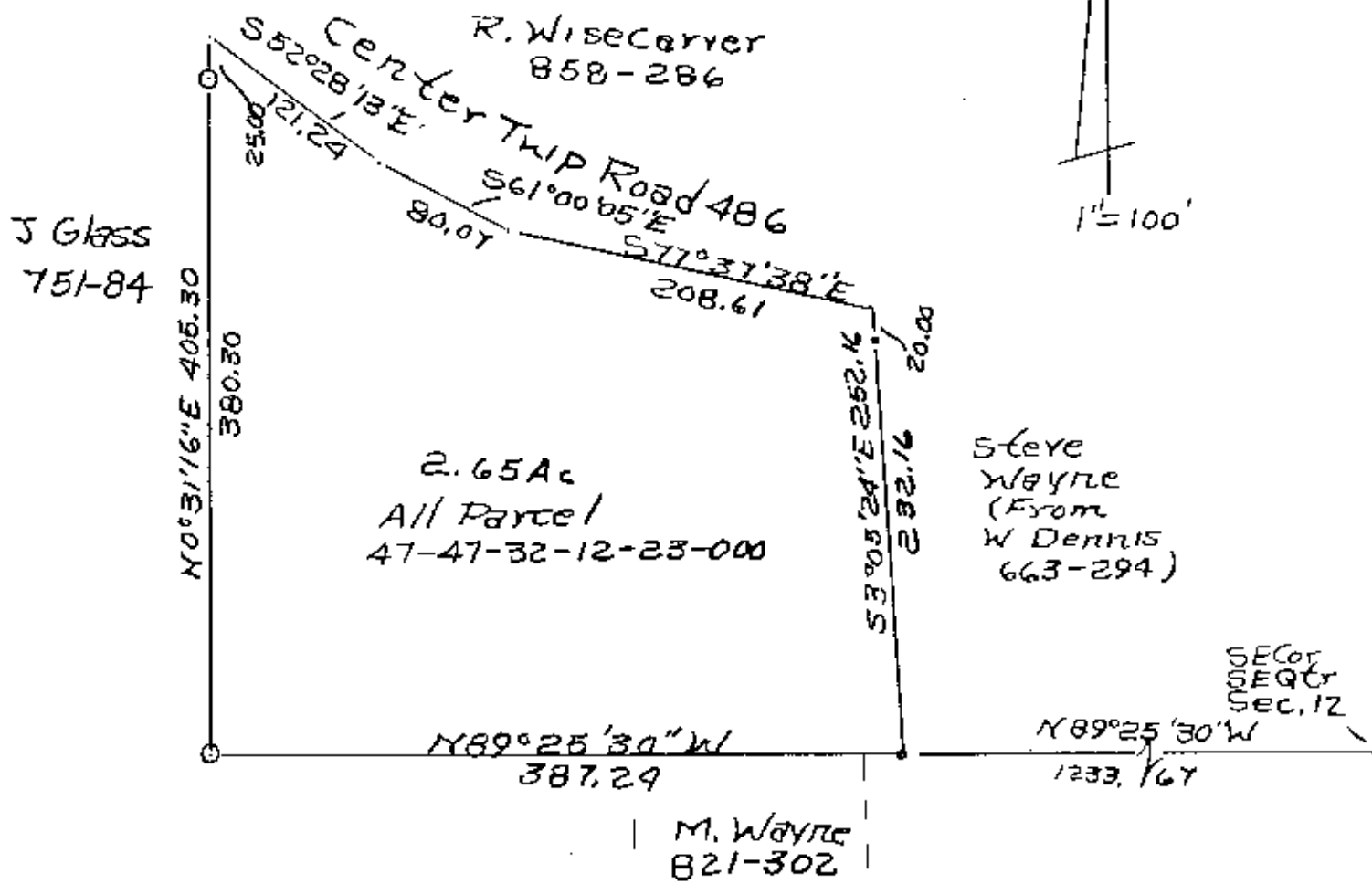

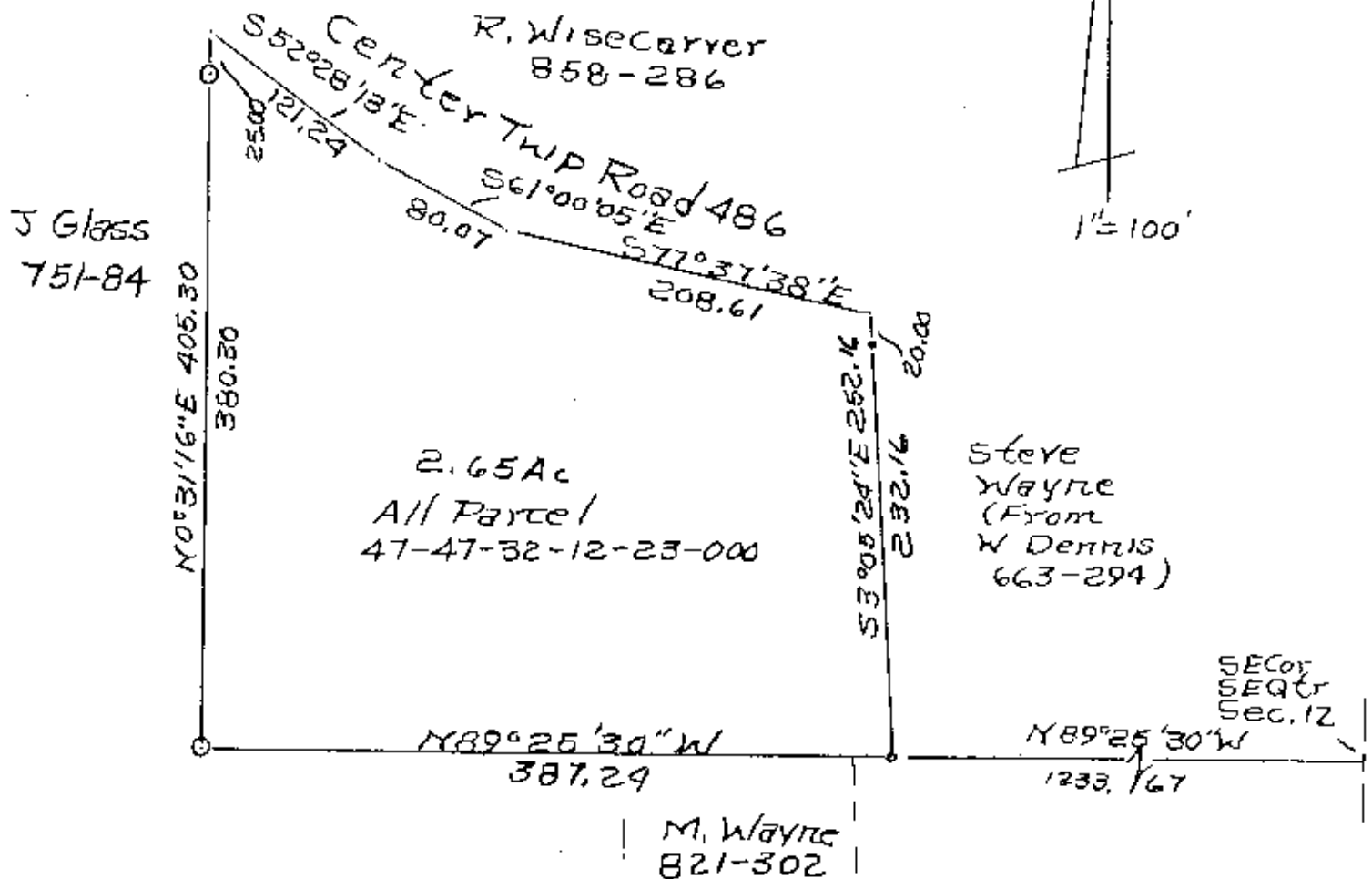
