Beginning at a stone at the Northwest corner of the South Half of the Southeast Quarter of Section 11; thence South $1^{\circ} 21' 24''$ East 1320.00 feet to an iron pin on the South line of Quarter Section; thence North $89^{\circ} 12' 11''$ East 2559.74 feet to an iron pin at the Southeast corner of said Quarter Section; thence North $1^{\circ} 49' 58''$ West 1306.05 feet to an iron pin on Half Section line; thence South $89^{\circ} 31' 13''$ West 2548.98 feet to a stone the place of beginning and containing 76.99 acres more or less.
