BEING A PART NORTHWEST QUARTER OF SECTION 14, TOWNSHIP 17, RANGE 15, OF THE CONGRESS LANDS EAST OF THE SCIOTO RIVER, NEWTON TOWNSHIP, MUSKINGUM COUNTY, OHIO AND BEING FURTHER DESCRIBED AS FOLLOWS:

BEGINNING AT AN EXISTING IRON PIN (1/2 INCH ROD) AT THE NORTHEAST CORNER OF SAID NORTHWEST QUARTER OF SECTION 14; THENCE NORTH 89 DEGREES 10 MINUTES 15 SECONDS WEST 244.55 FEET ALONG THE NORTH LINE OF SECTION 14 TO A POINT IN THE CENTER OF WORKMAN ROAD (TOWNSHIP ROAD 273), SAID POINT BEING THE PLACE OF BEGINNING OF THE TRACT HEREIN INTENDED TO BE DESCRIBED;

THENCE CONTINUING ALONG THE CENTER OF SAID WORKMAN ROAD SOUTH 66 DEGREES 25 MINUTES 55 SECONDS WEST 478.42 FEET TO A POINT, SAID POINT BEING THE NORTHEAST CORNER OF A 5.065 ACRE TRACT CONVEYED TO S. AND B. AULT (DEED VOLUME 1109, PAGE 93 OF THE MUSKINGUM COUNTY DEED RECORDS, ALSO SAID POINT BEING NORTH 06 DEGREES 33 MINUTES 10 SECONDS EAST 195.87 FEET FROM AN EXISTING IRON PIN;

THENCE ALONG THE CENTER OF SAID WORKMAN ROAD AND ALONG THE NORTH LINE OF SAID AULT TRACT SOUTH 71 DEGREES 00 MINUTES 44 SECONDS WEST 276.92 FEET TO A POINT;

THENCE ALONG THE CENTER OF SAID WORKMAN ROAD AND ALONG THE NORTH LINE OF SAID AULT PROPERTY NORTH 78 DEGREES 06 MINUTES 32 SECONDS WEST 71.56 FEET TO A POINT;




