

DESCRIPTION OF SURVEY FOR THOMPSON FAMILY

Situated in the State of Ohio, County of Muskingum, Township of Newton:

Being part of Section 17, Township 15, Range 14, of the Congress Lands East of the Scioto River, further **being part of** the Timothy G Thompson and Susan Thompson property recorded in **Official Record Volume 2641, Page 1** of said county's deed records, further **being part of** Muskingum County Auditor's **Parcel Number 47-39-01-11-000**, and more particularly described as follows;

Commencing at the unmarked common corner for Lots 15 and 16 of Gladstone's Addition recorded in Plat Book 3, Page 2;

- TIE-1 THENCE North 63 degrees 20 minutes 26 seconds West 19.01 feet** along the Southwest line of said Lot 15 and common line for the Nancy K Thompson ETAL property recorded in Official Record Volume 2623, Page 546 to an iron pipe (found) at a common corner for said Timothy/Susan Thompson and Nancy Thompson properties;
- TIE-2 THENCE South 29 degrees 06 minutes 27 seconds West 114.61 feet** along a common line for said Timothy/Susan Thompson and Karen Thompson properties to an iron pipe (found) at a common corner of said Timothy G Thompson and Susan Thompson property and for the Todd W Thompson property recorded in Official Record Volume 2623, Page 543, being the place of beginning for the property herein intended to be described, passing an iron pipe (found) at 49.54 feet;
- #1- THENCE South 29 degrees 06 minutes 27 seconds West 19.56 feet** along a common line for said Timothy/Susan Thompson and Karen Thompson properties to an iron pipe (found);
- #2- THENCE South 18 degrees 03 minutes 27 seconds East 77.05 feet** through said Timothy/Susan Thompson property to an iron pin (set);
- #3- THENCE North 84 degrees 50 minutes 07 seconds West 98.21 feet** continuing through said property to an iron pin (set);
- #4- THENCE North 18 degrees 03 minutes 27 seconds West 126.98 feet** continuing through said property to an iron pipe (found) at a common corner for said Timothy/Susan Thompson and Todd Thompson properties;
- #5- THENCE South 63 degrees 45 minutes 35 seconds East 49.60 feet** along said properties to an unmarked point;
- #6- THENCE North 46 degrees 32 minutes 41 seconds East 20.10 feet** continuing along said properties to an iron pipe (found);
- #7- THENCE South 63 degrees 58 minutes 13 seconds East 70.91 feet** continuing along said properties to the place of beginning, **containing 0.24 acres.**

Not to be used as a separate building site or transferred as an independent parcel in the future without planning commission approval in accordance with applicable subdivision regulations. Parcel to be combined with adjacent Auditor's Parcel Number 47-42-06-22-000.

The bearings within this description are based on State Plane Coordinate Grid (Ohio South 1983) derived from GPS Observations. Iron pins set are 5/8 inch rebar 30 inches long capped C R Harkness PLS6885.
