

## DESCRIPTION OF SURVEY FOR S. TIPTON

JOB#811-2

Situated in the State of Ohio, County of Muskingum, Township of Newton:

Being part of the Northwest Quarter, of Section #17, Township #15, Range #14, of the Congress Lands East of the Scioto River, being all of the S. Tipton property as described in deed reference Deed Book Volume 1125, Page 578 of said county's deed records, also being all of Muskingum County Auditor's Parcel Number 47-39-01-18-000, and more particularly described as follows;

Commencing at the Southwest corner of Lot #2 of Gladstone Addition to the Village of White Cottage as recorded in Plat Book 3, Page 2 of said county's plat records; thence (by deed) N 66 00 00 W 262.00 feet along the North line of Orchard Street to a corner of the Barbara Renick property as described in deed reference Deed Book Volume 794, Page 283, in the center of Limestone Valley Road (County Road #652) previously known as Maysville Pike, being the place of beginning for the property herein intended to be described;

- #1- thence N 51 17 50 W 185.97 feet along the common line for said Renick and Tipton properties to an iron pin (found disturbed) at the common corner for said Renick and Tipton properties, also being on a line of the Paul and Margie Schooley property described in deed reference Deed Book Volume 1104, Page 117, passing a concrete monument (found) at 23.65 feet;
- #2- thence N 32 09 00 E 50.00 feet along a common line for said Tipton and Schooley properties to an iron pin (found) at a common corner;
- #3- thence S 51 16 00 E 34.23 feet continuing along a common line for said Tipton and Schooley properties to an iron pin (found) at a common corner for said Schooley property and the D & C Spencer property described in deed reference Deed Book Volume 734, Page 140;
- #4- thence S 51 16 00 E 164.00 feet along the common line for said Spencer and Tipton properties to the center of said road, passing an axle (found) at 132.03 feet;
- #5- thence S 46 14 00 W 50.00 feet along the center of said road to the place of beginning, containing 0.219 acres.

The bearings within the description are based on a survey of the B & G Emory property by Stephen M. Bowman PLS #7135 currently the D Henderson property. Bearings are shown in a format of Degrees, Minutes, and Seconds. Iron pins (set) are 5/8" rebar with identification caps (C.R.Harkness P.L.S.6885).






