**Note #1-** Apparent title Gap of 6 feet between current deed descriptions. Original transfer of the Northern portion of Lot 4 was not found. Quit Claim Deed recorded in DB Vol. 679, Page 9 established the Northern portion as 20 feet by 66 feet. Deeds for the remaining portion of Lot 4 list a depth of 106 feet. Occupation for over 30 years include 112 feet.

**Note #2-** Survey of Lot 5 by Richard Daniels was not used and does not appear to match other surveys, plat information, or occupation within the block.

**Note #3-** Surveys and occupation of Lots 29-37 do not parallel or create a nominal right of way width for Limestone Valley Road.
