Beginning at an iron pin found at Southeast Corner of the Southwest Quarter of Section 14; Thence along Section line North $89^{\circ}35'31''$ West 607.45 feet to a iron pin found in the center of Township Road 264 passing a stone found at 586.86 feet; Thence in center of Township Road 264 the next two courses are distances, North $10^{\circ}14'14''$ West 126.43 feet to a point, and North $00^{\circ}09'14''$ East 53.04 feet to a point; Thence leaving said road and along split line of Volume 1104, page 82 North $42^{\circ}00'59''$ East 541.69 feet to a iron pin set, passing a iron pin set at 30.86 feet; Thence along split line South $81^{\circ}56'30''$ East 283.70 feet to a iron pin set; Thence along East line of Southwest Quarter of Section 14 South $01^{\circ}26'35''$ West 544.64 feet to the Place of Beginning. Containing 6.68 Acres more or less.

Bearings are based on the South line of Section 14 bearing North $89^{\circ}35'31''$ West.

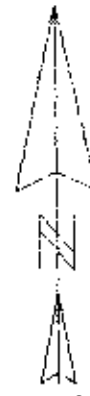
Iron pins set are No. 5 reinforced bars 30 inches long with plastic I.D. caps.

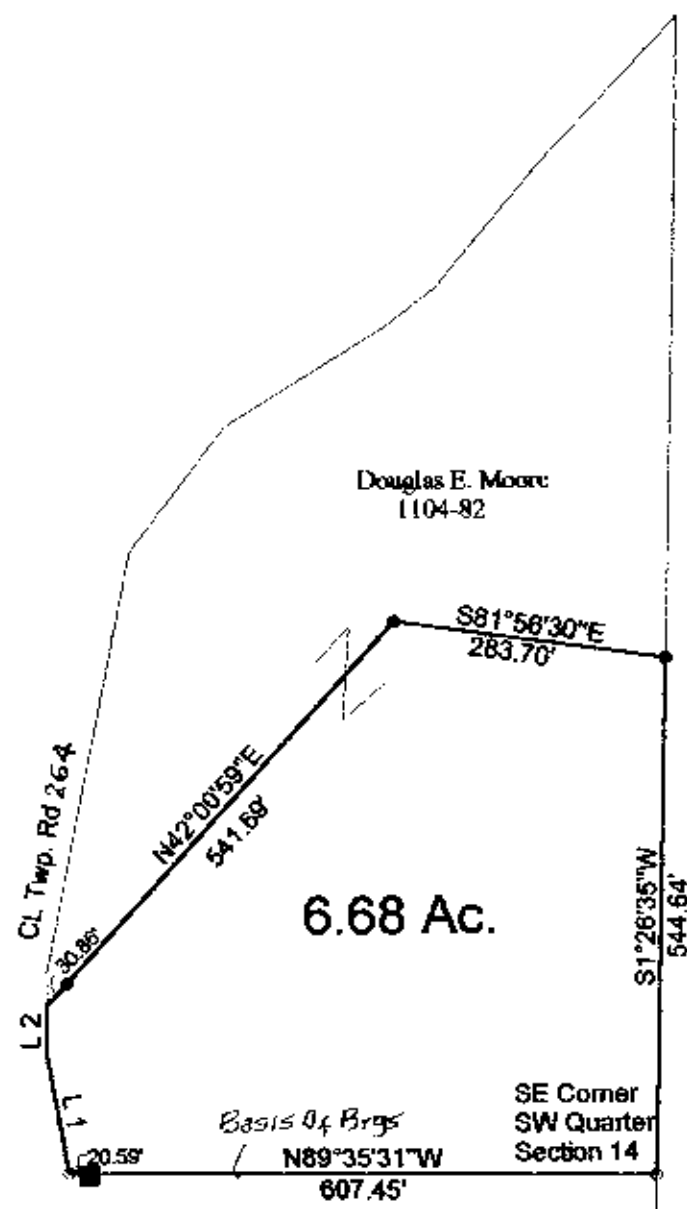
