for their joint lives, remainder to the survivor of them, whose tax mailing address is:

the following real property:

Being a part of land conveyed to Ellis Vernon and Judy Vernon from Northwest Financial America, Inc., as described in Deed Volume 1507, Page 912, and recorded in the Muskingum County Recorder's office.

Located in the Southeast quarter of Section 14 and in the Northeast quarter of Section 23, Township 15, Range 14, Newton Township, Muskingum County, State of Ohio.

Beginning at an iron pin found with "Dadeco" I.D. cap at the Southeast corner of Section 14; thence along the East line of Section 23, South 00 deg. 54 min. 33 sec. West - 165.40 ft. to the center of County Road No. 46 - Darlington Drive (ref. passing over an axle shaft found at 139.90 ft.); thence along the center of the road the following five courses and distances:

- 1) North 50 deg. 34 min. 02 sec. West - 188.13 ft.
- 2) North 48 deg. 58 min. 17 sec. West 87.01 ft.
- 3) North 43 deg. 08 min. 27 sec. West - 41.28 ft.
- 4) North 37 deg. 03 min. 30 sec. West - 103.92 ft.
- 5) North 33 deg. 55 min. West - 112.62 ft. to a mag nail set; thence leaving the road and along the center of an existing driveway and a 20 ft. wide right-of-way, North 16 deg. 50 min. 17 sec. East - 34.48 ft. to a 5/8 inch rebar pin set; thence North 24 deg. 00 min. 43 sec. West - 92.63 ft. to a 5/8 inch rebar pin set; thence North 03 deg. 44 min. 43 sec. West - 74.21 ft. to a 5/8 inch rebar pin set; thence North 24 deg. 39 min. 17 sec. East - 109.97 ft. to a 5/8 inch rebar pin set; thence North 34 deg. 30 min. 17 sec. east - 53.42 ft. to a 5/8 inch rebar pin set; thence North 45 deg. 19 min. 17 sec. East - 60.88 ft. to a 5/8 inch rebar pin set; thence North 56 deg. 13 min. 17 sec. East - 237.85 ft. to a 5/8 inch rebar pin set; thence South 87 deg. 05 min. 43 sec. East - 94.29 ft. to a 5/8 inch rebar pin set in the East line of Section 14 and being at the terminus of the 20 ft. wide right-of-way; thence along the East line of Section 14, South 00 deg. 54 min. 33 sec. West - 723.73 ft. to the place of beginning and containing 5.66 acres, more or less.

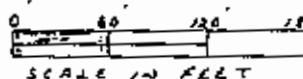
