

Tyler Jr., Vol. 430, Page 215, South $51^{\circ} 03' 00''$ East 99.26 feet to an iron pin set; thence along J. Butler, Vol. 526, Page 249, South $4^{\circ} 31' 08''$ West 246.65 feet to an iron pin set; thence along J. Butler, Vol. 569, Page 860, North $85^{\circ} 15' 00''$ West 143.34 feet to the place of beginning, containing 0.729 acres more or less.


