15-09-000 (known as unrecorded Lot 16 and 17).

Commencing at a stone found at the Northwest Corner of the Northeast  
Quarter of Section 15; Thence North  $89^{\circ}35'07''$  East 118.28 feet on Section Line  
to a point; Thence South  $00^{\circ}24'53''$  East 50.00 feet to an iron pin; Thence South  
 $00^{\circ}14'39''$  West 80.83 feet to an iron pin the place of beginning; Thence South  
 $89^{\circ}45'21''$  East 120.00 feet to an iron pin; Thence South  $00^{\circ}14'39''$  West along  
Rodayle Drive 121.77 feet to an iron pin; Thence along Rodayle Drive the next 2  
courses and distances on a 40.00 foot radius curve to the right to chord of  
which bears South  $45^{\circ}04'33''$  West 56.40 feet to an iron pin, and South  
 $89^{\circ}54'27''$  West 80.24 feet to an iron pin; Thence North  $00^{\circ}14'39''$  East 162.21  
feet to the place of beginning containing 0.438 Acres more or less.

Bearings are based on the North Line of the Northeast Quarter bearing North  
 $89^{\circ}35'07''$  East.

Iron pins set are No. 5 reinforced bars 30 inches long with plastic ID caps.

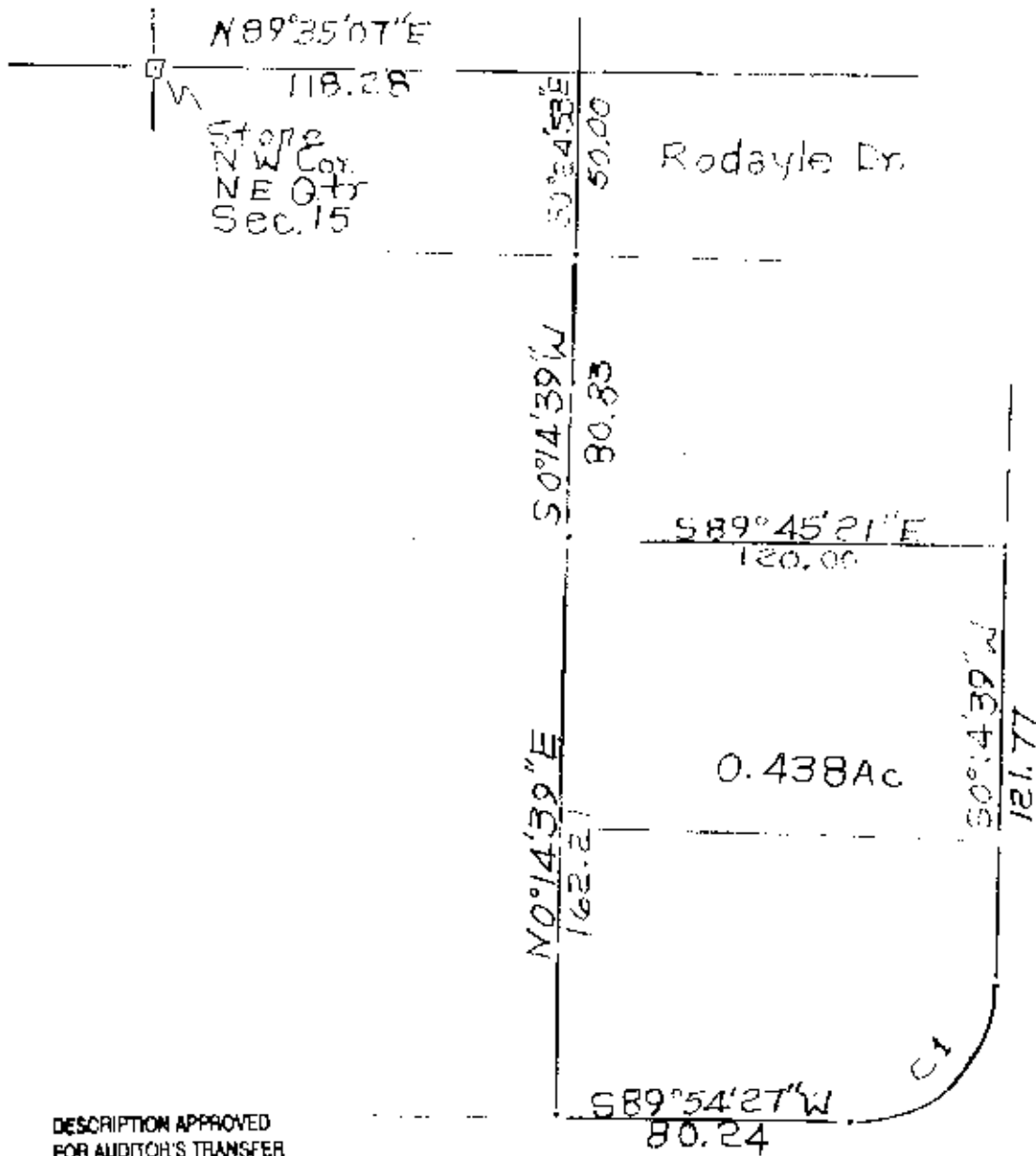
