**LEGAL DESCRIPTION**

Situated in the State of Ohio, County of Muskingum, Township of Newton, and being part of the southeast quarter of Section 13, Township 15, Range 14, and being all those lands intended to be described in Deed Volume 1723, page 361; being further bounded and described as follows:

**Beginning** at an iron pipe found at the northeast corner of the southeast quarter of Section 13, **thence, south 01 degrees – 37 minutes – 39 seconds west, 914.05 feet**, along the west line of those lands now or formerly owned by J. Ludwig (508/506) and the east line of said Section 13, to an iron pin set;

**Thence, north 88 degrees – 54 minutes – 09 seconds west, 1626.29 feet**, along the north line of those lands now or formerly owned by J. Ludwig (1822/901), to a point, passing an iron pin found at 1597.45 feet;

**Thence, north 01 degrees – 08 minutes – 12 seconds east, 635.68 feet**, along the east line of those lands now or formerly owned by Ace Mining Company (592/175), to a point in Tipton Road (Township Road #74);

**Thence, south 88 degrees – 22 minutes – 59 seconds east, 763.96 feet**, along the south line of those lands now or formerly owned by G. & K Peairs (1743/108), to an iron pin set, passing an iron pipe found at 30.47 feet;

**Thence, north 01 degrees – 29 minutes – 14 seconds east, 290.49 feet**, along the east line of said Peairs lands to an iron pipe found;

**Thence, south 88 degrees – 33 minutes – 31 seconds east, 870.43 feet**, along the south line of those lands now or formerly owned by T. Fitz (1104/517), to the **point of beginning**, and **containing 29.353 acres more or less.**

Subject to all legal highways and easements, whether recorded or implied.

Iron pins set are 5/8 rebar with yellow identification cap (FINLEY S-7222).




