COMMENCING AT AN IRON PIN FOUND AT THE SOUTHEAST CORNER OF LOT #52 OF CANNONS THIRD ADDITION TO EAST FULTONHAM, AS RECORDED IN PLAT BOOK 4, PAGE 144A, THENCE, SOUTH 05 DEGREES - 28 MINUTES - 02 SECONDS WEST, 16.00 FEET TO AN IRON PIN SET; THENCE, CONTINUING SOUTH 05 DEGREES - 28 MINUTES - 02 SECONDS WEST, 48.56 FEET TO A NAIL SET IN AN ASPHALT DRIVE; THENCE, SOUTH 35 DEGREES - 31 MINUTES - 45 SECONDS WEST, 171.71 FEET TO A CONCRETE MONUMENT FOUND; THENCE, NORTH 84 DEGREES - 40 MINUTES - 00 SECONDS WEST, 313.66 FEET TO AN IRON PIN SET, AND THE TRUE POINT OF BEGINNING FOR THE PARCEL HEREIN INTENDED TO BE DESCRIBED; THENCE, CONTINUING NORTH 84 DEGREES - 40 MINUTES - 00 SECONDS WEST, 41.95 FEET TO AN IRON PIN FOUND; THENCE, SOUTH 69 DEGREES - 04 MINUTES - 00 SECONDS WEST, 86.79 FEET TO A POINT ON THE NORTH BANK OF BUCKEYE CREEK; THENCE, NORTH 05 DEGREES - 21 MINUTES - 30 SECONDS EAST, 235.66 FEET TO AN IRON PIN SET ON THE SOUTH LINE OF A SIXTEEN (16) FOOT ALLEY, PASSING AN IRON PIN SET AT 20.66 FEET; THENCE, SOUTH 84 DEGREES - 38 MINUTES - 12 SECONDS EAST, 119.82 FEET ALONG SAID ALLEY TO AN IRON PIN SET; THENCE, SOUTH 05 DEGREES - 22 MINUTES - 31 SECONDS WEST, 197.19 FEET TO THE POINT OF BEGINNING, AND CONTAINING 0.5767 ACRES MORE OR LESS.

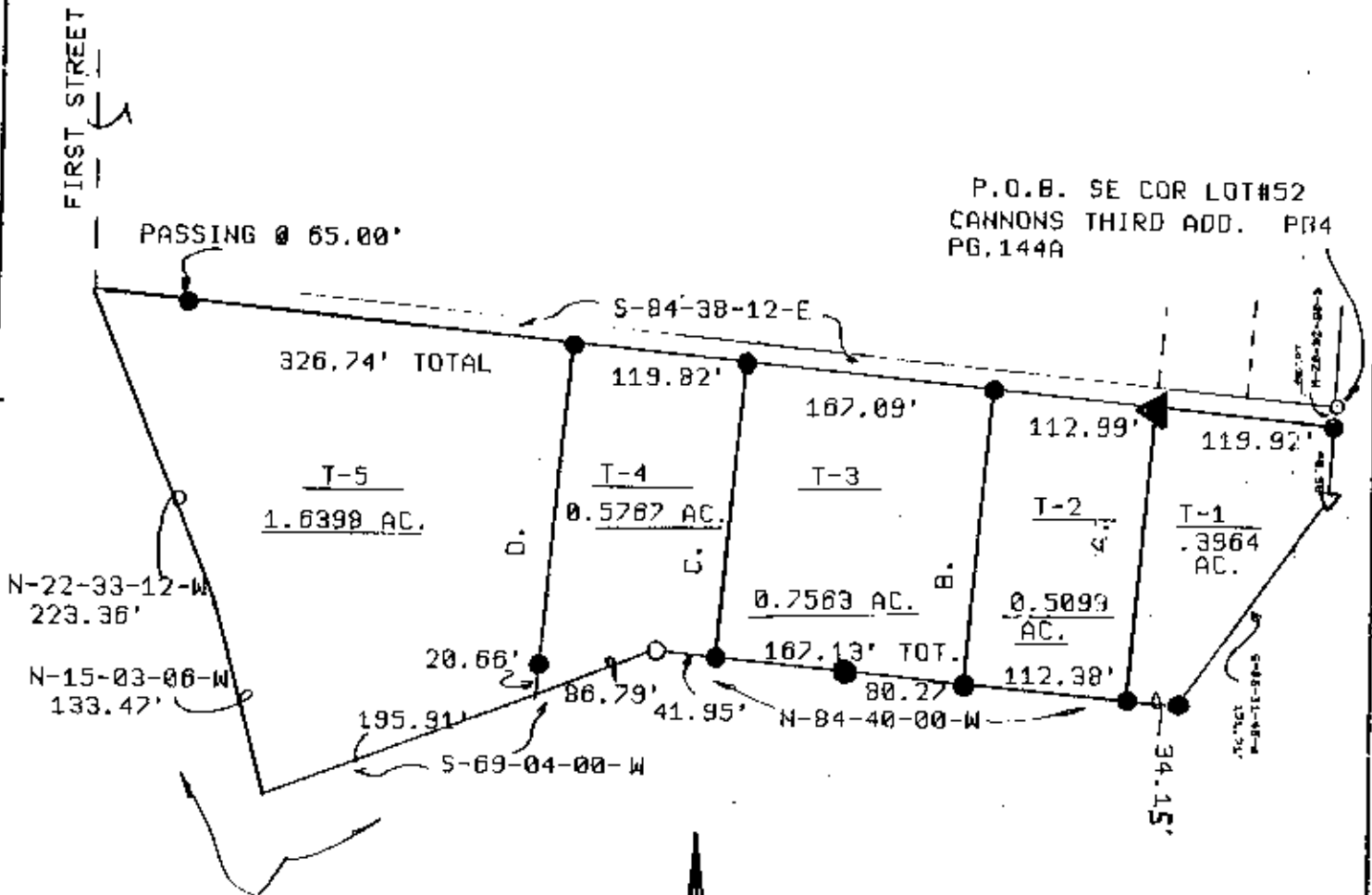
